2. Chesapeake Bay Trust ("CBT")

Presentation

- Kathy Somoza, Senior Program Officer
- The CBT is a nonprofit organization that seeks to empower diverse groups to take actions which enrich natural resources and local communities in the Chesapeake Bay region.
- Environmental Justice Initiatives at the Trust (3)
 - 1. Mid-Atlantic Environmental Justice Fund
 - Awarded \$17M through the U.S. Forest Service

- 1st participatory EJ fund in the Mid-Atlantic. There are oversight committees at all steps of the award process.
- 11 project partners including 4 EJ hub leads
- 3 project tracks capacity building, workforce development and green infrastructure and resiliency
- Proposal to the National Oceanic and Atmospheric Administration for \$75M in Fall '24
- 2. Community Based Organization ("CBO") Capacity Building Initiative
 - EPA award to MDE
 - Improve air quality and community resiliency
 - Key partners conduct outreach to provide technical assistance
 - Regions chosen based on their existing poor air quality
 - One goal is a measurable increase in the number of applications from organizations that have not previously applied to watershed resilience- and restoration-focused grant programs and represent historically under-engaged communities
- 3. Supplemental Environmental Projects an environmentally beneficial project or activity that protects and/or improves the environment and/or reduces risks to public health
 - Curtis Bay and Surrounding Communities funding up to \$750,000
 - Patapsco and Back River Watersheds funding up to \$1,900,000 improve water quality in two watersheds opening the funding opportunity in April to May

Questions and Comments

- Commissioner Wilson stated that he is the Director of the Mid-Atlantic Environmental Justice Fund. He also noted his role as Co-Director of the Thriving Communities Technical Assistance Center for EPA Region 3.
- Commissioner Smith asked if local governments are eligible for funds from the Mid-Atlantic Environmental Justice Fund. Kathy replied that she believed they were but wanted to confirm.
- Commissioner Smith asked if the Trust is administering the CBO grant. Kathy stated that MDE was awarded the grant and the Trust's role will be to handle the program's building and infrastructure.
- Commissioner Smith asked if the SEP funding in Curtis Bay was annual or the total allocation. Kathy responded that that was the total amount, but there are other sources of funding for Curtis Bay.
- Commissioner Wilson added that there is a funding opportunity for Curtis Bay in the Community Change Grant.

3. CEJSC 2024 Meeting topics & calendar

- Curtis Bay and Lothian are tentative sites to host a CEJSC meeting. Kellie Gaither will follow up regarding Curtis Bay.
- Commissioner Wilson would like each state agency to submit to the Commission their annual EJ strategic plan and annual report.
- Chair Burke wants to know if each state agency has an EJ Coordinator and if they have an EJ plan. She would like Commissioner Delegate Boyce to be a part of the conversation about the Commission's EJ concerns.
- Sarah Abel, Maryland Department of Planning's new Chief Sustainable Growth Officer would like to work with the Commission on Maryland's Planning Vision.
- Commissioner Wilson wants to create a criteria or baseline for the state agencies to report back to the Commission on their strategic EJ plans.
- Mariah Davis is working on an EJ policy for the Department of Natural Resources. She agreed that there should be a common baseline for all agencies.
- Nadya Chehab is the Maryland's Department of Agriculture's new EJ Coordinator working on EJ and Equity as well as Climate Change.
- Commissioner Rehr stated she's willing and available to assist.
- Commissioner Smith would like to do something for Earth Day.
- Commissioner Wilson works for the University of Maryland and has infrastructure to support the Commission. Also, he noted a symposium he is planning.
- Chair Burke would like the Commission to attend the symposium.
- Commissioner Molock would like the Commission to view the film Eroding History.
- Commissioner Rehr recommended MDE and CEJSC host a public screening of the film Eroding History.

4. Annual Report 2022-2023

- The CEJSC Annual Report is posted on the MDE website.
- Joseph Griffiths asked if other states had passed legislation requiring county and municipal governments to review their planning and zoning laws to identify and protect overburdened and underserved communities. Commissioner Wilson commented that California had passed legislation to have EJ in each county plan.
- Commissioner Chandar asked if there are models between health equity and EJ.
- Commissioner Hammond commented that the Protecting State Waters from PFAS pollution Bill HB1153 and SB956 crossed over to the Senate.
- Chair Burke would like recommendations for the next annual report to the Commission by July.

5. Public Comment

- Patrick DeArmey is a staff attorney at the Chesapeake Legal Alliance and works in the Lothian community. There are plenty of zoning issues that have created EJ problems. He is currently working with some mobile home communities and asks if there is anyone who does renters and tenants rights in Maryland. The company that owns the mobile home park is Horizon Land Management LLC.
- Patrick added that the Chesapeake Legal Alliance was the law firm that represented Bluewater Baltimore in the lawsuit against the Patapsco River and Back River wastewater treatment plant that resulted in the Chesapeake Bay Trust Supplemental Environment Project.
