[MarquipWardUnited](#) recently completed a seven-week study of the mail received at their facility. The company found it was receiving 3,000 pounds of unwanted mail each year - 15 percent of which was addressed to individuals no longer with the company. MWU is working to eliminate unwanted mail by removing themselves from paper mailing lists. This will reduce time spent sorting, delivering, disposing of unwanted mail and ultimately, the cost to have the mail hauled away.

What started as a family day trip to Havre de Grace (HdG) this summer ended up being a grand tour of the town's Maryland Green Registry members. The first sign of the town's participation in the program was when we spotted the [Havre de Grace Seafood Festival](#) Smart Car with its colorful wrap featuring the Maryland Green Registry logo. This HdG annual festival encourages all vendors to use compostable products and prohibits the use of polystyrene products.

Next, we came across another member, the [Havre de Grace Decoy Museum](#), and stopped in. Gift shop manager, Samantha Costillo, welcomed us and pointed out their new LED lighting and recycling efforts. The museum also requires its artists to use reclaimed wood in carving new decoys.

Later, strolling along the shops of Union Avenue, we noticed the Maryland Green Registry decal on the door of [Flicker Scents](#) where owner Jennie Horn sells clean-burning soy wax candles sold in fully compostable bags. The store also allows its customers to return the glass candle containers so that they can melt down the remaining wax and recycle them.

Jennie then sent us across the street to meet Barbara Wagner, the force behind the promotion of the Maryland Green Registry in Havre de Grace. Barbara and her husband own [Bahoukas Antique Mall](#) which sells antiques and collectibles. In addition to promoting the re-use of these quality items, they have also created GreenJoy, a line of eco-friendly products, including handbags and wine totes made from beautiful estate linens. Barbara is a former city council member and fully committed to greening HdG. She's active with the [Havre de Grace Green Team](#), a source of great info and tips for the community.

Walking down to Hutchins Point, we spotted another member, the [Lantern Queen Riverboat](#), returning from a tour. The Lantern Queen is an energy efficient vessel committed to green practices and to educating passengers about the Bay's natural features. Located next to the Lantern Queen is a parasail company so we decided to get a bird's eye view of the Bay. As the parasail lifted us up high over the

Chesapeake, we spotted down below on the banks of the Susquehanna River yet another Maryland Green Registry member, the [Perry Point VA Medical Center](#). Perry Point is the largest VA inpatient facility in Maryland and maintains a robust environmental management system that ensures that they set and work toward annual environmental goals.

This summer, Havre de Grace commemorated the 200th anniversary of the May 13, 1813 British attack on their town with the motto "Resolve, Resilience, Remembrance." Having now visited these member organizations, I think they can also claim the 3Rs of reducing, reusing and recycling.

Thank you to all the HdG members for all you do to reduce your environmental impacts and to Barbara Wagner for promoting participation in the Registry.
