- **2. Working Group Updates** *Reminder Please report any changes to the 2018 Work Plans There have been no changes to the working group work plans.*
 - Adaptation and Response Working Group Matt recapped the Climate Leadership Academy Kick-off. DNR will keep the SC and Commission up to date as things progress.
 - Education, Communication, and Outreach Working Group Hannah reported that ECO
 has been developing ideas for outreach on the GGRA Draft Plan and the MCCC
 Report. We have been identifying stakeholders and talking about best methods.
 Later this year, ECO would like feedback from MCCC and the SC.
 - Mitigation Working Group The MWG SC has been working on new processes in response to concerns where people would like more discussion and less presentations. The next meeting will test a plan to have no presentations, but a panel discussion based around 4 questions developed by the Steering Committee. If a panel member has materials they would like to share, they will be sent ahead of time. Also, there will be a special session after the meeting to discuss modeling options.
 - Scientific and Technical Working Group STWG is in talks with MDE staff about a
 project designed to filling gaps on GGRA data. They do not have dates or
 participants just yet.

Various suggestions were made. The group considered longer meetings, though they were open to the idea of having special topics before or after a meeting, such as the Modeling Sub-Group MWG will have next week. They were also open to the idea of phone calls or webinars highlighting a topic or giving updates we tend to do at meetings. Everyone favors more discussion, less presentations. It

was suggested that we may not need updates from every working group every time, but most people would like to have an update from each group. However, the staff/steering committee should determine if one group needs longer time to cover more info. The SC generally agrees with the notion that we end up rushing the reports and this leads to a gap in information. It was also suggested we might do a summary of the points highlighting the MWG discussion that could be shared with the larger group, if it is not too much work
