Why should I recycle my mercury thermometer?

Mercury is a toxic heavy metal substance that can cause serious impact to human health and the environment. One of the largest household sources of mercury is a glass-mercury thermometer that can easily be broken.

If a mercury thermometer is broken, toxic mercury can be released into the home. Contact with mercury can cause serious health consequences that affect the brain and nervous system.
