Improvements to MDE's Permit Tracking Database

Taking advantage of the latest information and computer technology, the Maryland Department of the Environment (MDE) has continually upgraded its permit tracking database system (PERTS) since its creation in 1994. PERTS was originally created to track limited information about major permits with public participation requirements. PERTS has recently been upgraded and expanded to track such things as site-specific information for certain types of facilities, billing information, special permit conditions and limits, milestones in the permitting process, money back guarantee requirements, and correspondence between MDE and applicants concerning specific applications. The database currently tracks 45 percent of the

permits MDE issues. Continued expansion of PERTS will allow additional MDE permit applications to be tracked and will eliminate many obsolete, standalone, year 2000 noncompliant databases currently in use throughout the department.

A unified database such as PERTS will improve data consistency, availability of multi-media information, universal access to permitting information, and centralize programming support. MDE is working to improve its web site and soon will have information from PERTS available online so that our customers also can use the technology.

Neutron products, Inc. – Montgomery County
On October 15, 1998, MDE issued a corrective order and assessed an administrative penalty in the amount of \$25,000 against this radioactive materials processing facility. This action was taken as a result of the company's failure to conduct random inspections of a specific storage area and failure to conduct post-inspection management reviews. The company also failed to keep proper decommissioning records and stored depleted uranium in an unsecured manner and without proper signage. The company has been cited for similar deficiencies in the past. The order requires Neutron Products, Inc. to take specific measures to correct the deficiencies.

Status: Case pending. Ref#RHP-98-18
Corun & Gatch – Harford County
MDE has settled an air pollution enforcement case against this Harford County asphalt production plant. The plant was cited on numerous occasions by ARMA and EPA inspectors for violating visible emission, dust, and nuisance regulations. In response, MDE issued a corrective order and an administrative penalty. The company has since achieved compliance through corrective actions approved by ARMA, but settlement of the penalty remained an issue. A hearing was scheduled to resolve the penalty, but prior to the hearing the company agreed to pay a \$20,000 penalty to settle the case.

Status: Resolved pending receipt of payment. Ref#98-MDE-ARMA-011-101
F. O. Day – Montgomery County
MDE issued a Corrective Order to this asphalt production plant located in Montgomery County for violations of visible emissions, odors, and permit conditions. This plant has been the source of numerous citizen complaints regarding odors from its operations. MDE is working closely with the Montgomery County Department of Environmental Protection on this case. The corrective order requires the Company to take expeditious actions to resolve their problems.
Status: Case pending. Ref# 98-09-03

Price Brothers – Harford County
MDE has finalized a Consent Order, with this Harford County concrete pipe production facility for violations of VOC and reporting regulations. In the settlement Price Brothers agrees to pay a \$38,000. Price Brothers achieved compliance by substituting non-VOC

materials in their process and complying with reporting requirements. The settlement order requires Price Brothers to continue operating so as to maintain continuous compliance.
Status: Resolved pending receipt of payment. Ref# 97-09-03

Interstate Corrrpack – Dorchester County
MDE assessed a \$4,200 administrative penalty against this eastern shore cardboard manufacturing and printing facility. Inspection revealed that Interstate installed and began operating a printing press in April 1998 without obtaining a permit. ARMA previously issued a corrective order requiring the company to cease operations until a permit was obtained. Interstate appealed the order and applied for the permit. The company has 30 days to pay the penalty or request a hearing.

Allegany County Commissioners – Allegany County
On October 9, 1998, a civil consent judgment was filed in the Circuit Court of Allegany County between MDE and the Allegany County Commissioners regarding violations of the NPDES permits issued to the George's Creek and Celanese Wastewater Treatment Plants. Under the terms of the Consent Judgment, Allegany County has agreed to implement improvements to the wastewater treatment plants to ensure compliance with discharge permit effluent limitations and to address excessive inflow and infiltration problems associated with the plants' sewage collection systems. In settlement of past violations, the County has agreed to pay a civil penalty of \$40,000, to be paid in annual installments over the next four years, and, within the next two years, to perform a supplemental environmental project worth \$200,000 to benefit water quality.
Status: The judge for the Circuit Court of Allegany County signed the order on October 15, 1998. (Reference # CJ-99-0041).

Maryland Jockey Club – Baltimore County
On November 6, 1998, MDE signed an administrative consent order with the MD Jockey Club regarding improvements for barnyard waste disposal at the Pimlico Race Track. The Consent Order requires the facility to initiate improvements to eliminate unauthorized wastewater discharges from cleaning manure and bedding from horse stables and from associated laundry operations. The Jockey Club has agreed to pay a penalty

of \$1,000 to the Clean Water Fund in settlement of past unauthorized discharges.
Status: Settled (Reference #CO-99-0047).

Bardon, Inc. – Montgomery County
On October 28, 1998, MDE signed an administrative consent order with Bardon, Inc. to settle Administrative Complaint, Order, and Penalty AO-98-0036 issued on January 7, 1998 for water pollution violations. Under the terms of the Consent Order, Bardon has agreed to pay a penalty of \$19,000 to the Clean Water Fund and to perform a supplemental environmental project to construct a recreational pond and to plant wildflowers.

Fahrney Keedy Home and Village – Washington County
On November 4, 1998, MDE signed an administrative consent order with the Fahrney Keedy Home in Boonsboro requiring improvements to the facility's wastewater treatment plant.
