Port aims to make site ship shape

The Maryland Port Administration is among many entities employing the Maryland Department of the Environment's Voluntary Cleanup Program (VCP) to investigate and clean up polluted sites that have been tagged for redevelopment.

In an effort to grow its automobile storage facilities smartly, the Port Administration turned to the VCP to give new life to the former Kurt Iron & Metal property located in the heavily industrialized Fairfield section of Baltimore City. Accessed from Childs Street, the property is bound on three sides by the Toyota and Masonville automobile terminals and on the north by the Patapsco River.

"This property will be used as an addition to the Port Administration's automobile terminal, providing valuable land to grow an important job-producing commodity for Maryland," said Port Planner Eldon Miller. "The Port Administration plans to raise the grade of the site to equal that of the adjoining properties." The area will be paved, explained Miller, but no permanent structures are planned.

Historically, the Maryland Shipbuilding & Drydock Company used the property to store and dispose of various items generated by its shipbuilding, shipbreaking and maintenance activities. Some of the disposed items were reportedly burned and the residual was landfilled on the property.

The Maryland Shipbuilding & Drydock Company also used the site as a sandblasting area to remove paint from ship components. Demolition debris from the Great Baltimore Fire of 1904 and the razing of the neighboring Maryland Shipbuilding & Drydock facility is also reported to have been disposed of on the property.

From 1987 to 2000, a succession of shipbreaking companies operated on the site, dismantling military and commercial ships, salvaging materials to sell, and disposing the rest -including petroleum products, PCBs, and asbestos containing materials.

As a result of these historical activities, a variety of paints, solvents, PCBs, waste oils, lubricants, and fuels have been generated, used, stored, and/or released on the property over the years. Portions of the property have also been used to store and/ or dispose of asbestos containing materi-

als, furnace slag, sandblasting grit, a variety of storage tanks, drums and containers, abandoned heavy equipment and vehicles, appliances, storage trailers and wood and metal debris.

In February 1999, MDE accepted a VCP application and supplemental information from the Port Administration to purchase and reuse the former shipyard.

The VCP provides a way for property owners and prospective purchasers to work voluntarily under the department's oversight to investigate and remediate properties. At the successful completion of a VCP project, the program participant receives either a No Further Requirements Determination or a Certificate of Completion for the eligible property. The No Further Requirements Determination states that the department does not have further require-

New legislation expands prior policies, goals

During its 2001 session, the Maryland General Assembly enacted several important pieces of legislation, aimed at protecting and preserving Maryland's fragile environment. Among the bills currently awaiting the governor's signature are those aimed at reducing the impact of urban sprawl on the environment, encouraging green buildings by providing tax credits for construction costs, authorizing the state to regulate intrastate oil pipelines, requiring medical labs to report the addresses of patients diagnosed with lead poisoning and prohibiting fever thermometers containing mercury from being sold in the

Governor Parris N. Glendening introduced several important legislative initiatives that will expand Maryland's leadership in Smart Growth under House Bill (HB) 302. The bill creates an Office of Smart Growth in the Governor's Office to examine and coordinate the many Smart Growth programs, events and services in the state.

"The Office of Smart Growth will jump start coordinated agency assistance to local governments, communities and developers pursuing infill or redevelopment projects in Priority Funding Areas and conservation projects in more rural areas," said Shari Wilson, MDE's

Groups takes action at start of 2001 ozone season

Representatives from Maryland's Department of the Environment (MDE) joined a host of environmentally concerned citizens April 26 at the Clean Air Partners Ozone Action Days Conference. This annual conference is held at the beginning of "ozone season," which in this area generally runs from mid-May until mid-September.

"The mission of the partnership is to improve air quality in the region through voluntary action," said Jim Potts, board chairman for Clean Air Partners. "Our Ozone Action Days Conference and other programs emphasize the importance of this mission."

Clean Air Partners (formerly known as Endzone Partners) is the air quality public education program for ground level ozone serving Northern Virginia, the District of Columbia and central Maryland.

Bill Burroughs, managing director of Clean Air Partners, said this year's conference had two main objectives. "We wanted to provide information that would help organizations start or improve their voluntary Ozone Action Days programs," Burroughs said. "We also wanted to provide environmental and health professionals with the most recent information about the health effects of ground level ozone."

Ground level ozone is formed when two categories of pollutants, nitrogen oxides (NOx) and volatile organic compounds (VOCs) "cook" in intense sunlight. Nitrogen oxides are the by-products of combustion from sources such as automobiles, lawnmowers and coal-fired power plants. Volatile organic compounds are substances such as vapors from gasoline, paints and solvents.

Ozone at ground level is harmful to humans and adversely affects the environment. In addition to lowering a person's resistance to certain illnesses such as colds and pneumonia, ozone at ground level can damage lung tissue and intensify heart and lung diseases. High concentrations of ground level ozone can also cause crop damage, and has been identified as part of the pollution problem in the Chesapeake Bay.

"We rely on Clean Air Partners to give wide publicity to 'code red - bad air alerts' that forecast episodes of unhealthy air due to high levels of ground level ozone in our area," said Phil Mendelson, D.C. councilman and chairman of the Metropolitan Washington Air Quality Committee (MWAQC). "In addition to its annual conference, the Partners also sponsor the Ozone Action Days Program participated in by 365 local organizations. These programs and the partners' annual media campaign help educate the public about voluntary actions individuals can take to protect their health and reduce the formation of ground level ozone. The work being done by Clean Air Partners is an important component in our efforts to reduce the adverse effects of ground level ozone in the region."

MDE, through its Air and Radiation Management Administration (ARMA), works directly with Clean Air Partners on the Ozone Action Days conference and other outreach programs.

Tad Aburn, program manager for planning in ARMA and a member of the Clean Air Partners Board, believes the partnership is an excellent example of public/private cooperation in pursuit of an important public health objective. "The work we do with Clean Air Partners is significant," Aburn said. "It has an immediate and direct benefit to individuals in our community and in the region."

Randy Moiser, who works in ARMA's Air Quality Planning Program, told *MDEnvironment* that in addition to its work with Clean Air Partners on Ozone Action Days, MDE will be introducing two new public outreach services on its air quality website this summer — AIRWATCH and e-Alert.

AIRWATCH is a real-time mapping system that will report air quality data on an interactive map of Maryland. Counties reporting ground level ozone will be color-coded based on the

Air Quality Index (AQI) scale with hourly updates from the air monitors located throughout the state. Real-time, sub-regional data can have a direct positive effect on health by encouraging people to adjust their activities based on their real, present risk. This will encourage sensitive individuals to avoid outside activity if their local air is unhealthy, according to Moiser.

MDE's e-ALERT is a free service that will automatically notify individuals by e-mail, text pager, and/or digital cellular phone anytime ground level ozone reaches unhealthy levels throughout Maryland.

Think you're safe from lead, think again

June 2-9, has been proclaimed by Governor Parris N. Glendening as Maryland's Childhood Lead Poisoning Prevention Week. For the past 13 years - and years af-

ter the phase out of lead in paints, gasoline and plumbing - there is still a need to promote lead poisoning prevention in Maryland.

Testing, awareness and education are tools every citizen can use to fight lead poisoning, a preventable disease. Children from six months to six years old are the main victims of lead poisoning. Young children can

get lead poisoning from their normal handto-mouth behavior if they are in an environment which has lead dust or lead paint. However, anyone who eats, drinks or breathes something which has too much lead can get lead poisoning.

Lead poisoning is usually a silent disease and may have permanent effects. A child who consumes a dangerous amount of lead may seem to be well, but lead can affect the

> blood, kidneys, nerves and brain causing learning disabilities and behavior problems.

> Prevention is the cure, and we all have a part to play, whether you are a rental property owner, parent, day care provider, health care provider, neighbor, relative, teacher, realtor, or contractor.

Take a moment to ask

yourself the following questions. Do you know a child that:

• Has ever lived in or stayed at a home or

- Develop criteria to determine environmental injustices and assess casual relationships between environmental justice and industrial/municipal/agricultural/commercial projects; and,
- Recommend options to MDE and other state agencies for addressing concerns or problems.

The commission's meetings are open to the public.

Hoyt leaves agency to start consulting firm

Maybe it started when he was a child wandering in the delights of a community lake. Or maybe it was the endearing moments spent in the New England woods. Regardless of the influence, all of his life Robert "Bob" Hoyt has had affection for the natural world.

Hoyt, the former assistant secretary at Maryland's Department of the Environment (MDE), recently reminisced about his stint with the state agency before his departure in March.

Although the walls of his office were empty, no longer displaying the numerous accolades of achievement and diplomas of knowledge obtained, Hoyt seemed energized, filled with the excitement of taking on the challenge of starting a new business.

Hoyt was appointed to his position at MDE in May 1997 after serving as director and associate professor at the Environ-

mental Law Clinic at Widener University's Harrisburg, Pa. campus.

"I'm most proud and feel best about being part of the whole team and working on all our issues," he said of his time at MDE. "The people here are great. I really enjoyed working with the people, and that's what I'll remember most."

Hoyt said he takes the most satisfaction in his work on the preservation of Chapman's Landing in Charles County, radium, air quality in reference to the Vehicle Emissions Inspections Program, the Performance Partnership with the U.S. Environmental Protection Agency, fostering stronger connections with citizens, citizen groups as well as environmental organizations, and the formation of the state Wetlands Restoration Committee.

"It's a string of projects...and being able to come in here everyday and work on something that was an important environmental issue...to help move the ball forward helping either the citizens of Maryland get answers or improve the environment."

Hoyt said MDE's internal change to a team approach is working very effectively, making the agency more efficient.

"We're making that effort to have our policies better known and the debate over our directions are all encompassing so others can really feel a part of that debate, as they should," the former assistant secretary said. "I've seen improvement in the decisions we're making on policy. They are being based on environmental gains so we can see what activities are most successful, most effective in reaching our goals, so when we're not doing that we can change. Those are good things. Those goals are reflected not only in our overall programmatic activities, but all the way down to individual job descriptions so each person can see how their work fits into the big picture of goals. Those are key things. Before, all the debates over doing more enforcement or more compliance assistance, they were done almost from a philosophical point of view.

"Now we can say let's look at what's working, and ask did it work, and we can fine tune based on facts and results not philosophies and generalizations that may or may not be grounded in reality. We've started down that road and I think that's great. We're on the right track. We're by no means there, but we need to continue," he added

Hoyt is not certain how his environmental ethic began but recalled his grandfather's house in the woods of a preserved area in Connecticut. "As a kid I used to walk all through the woods and spent a lot of time out there and that just stuck with me," he said. "I've always been that way.

"More than the woods though, I've always been drawn to the water," the former competitive swimmer said. "My mother used to tell me before I was a year old, if I was in a bad mood, she'd take me down to the lake we lived near and as soon as she'd put my feet in the water, I'd be happy. That's all it took and that's pretty much been the case."

After graduating from Princeton in 1973 with a degree in politics, and Rutgers Law in 1981, Hoyt spun his passion into a career that landed him positions as senior vice president for the Chesapeake Bay Foundation, executive director/staff attorney for the foundation's Pennsylvania office and deputy attorney general in the New Jersey Department of Environmental Protection.

"I just decided to spend my time working on improving and protecting water quality, but I think really its a respect for people, places and things," the Baltimore resident said. "You just don't treat the environment and others in certain ways...you respect them.

Hoyt's work life after MDE will blend an entrepreneurial spirit with his environmental knowledge and experiences. He and partner George Chmael, also formerly of the Chesapeake Bay Foundation, have opened EcoLogix, an Annapolis-based environmental consulting firm that specializes in strategic environmental planning.

"We're never going to be able to regulate respectful behavior or respect for the environment," he said "So if you're going to change behaviors you're really going to have to work directly with those entities whose behavior you'd like to see change. That's with businesses or whomever to try and instill that respect not because people have to, but because it makes sense."

In his off time, Hoyt enjoys the outdoors with his wife, Barbara, as he sails, skis and plays with his Portuguese water dog, Taj, which he calls "an amazing thing." He is also health conscious and a self-proclaimed jock. He has been on the "Body for Life"diet for some time in preparation for his run in October's Baltimore marathon, another first and lifetime achievement.

day care that is more than 20 years old?

- Has lived in or spent time in a home that is more than 20 years old and is being remodeled?
- Has contact with other children with lead poisoning?
- Eats, chews or licks things that are not food like paint chips, dirt, railings, poles, furniture or toys?

If the answer is yes to any of the above questions, the child may be at risk for lead poisoning. Talk to your doctor or your local health department for testing.

Lead poisoning can be prevented through healthy eating and good nutrition. The food that your child eats can make a difference in how much lead gets into your child's blood. Serve as many fresh and frozen foods as your budget will allow. Serve foods high in iron, calcium and vitamin C. Limit fats and oils such as fried foods, potato chips, french fries, sausage, bacon and butter. Foods high in

fats and oils make it easier for the body to absorb lead.

- **Q.** I obtained all the permits I needed to start my business. Do I need to do anything else for MDE?
- **A.** Over the past two months this column addressed some of the more common record keeping and compliance issues for air and waste permits. This month, it will cover some of the common requirements for water discharge permits.

As with other types of permits, the most important first step towards compliance is to carefully read the permit, which will contain important information about discharge limits, reporting requirements, sampling frequency, analysis methods and other information. General permits also contain compliance requirements, and the general permit should be read when a notice of intent to obtain coverage is submitted under a general permit.

Almost all water discharge permits contain monitoring and reporting requirements. Typically the result will be reported using a form called a discharge monitoring report or DMR. The permit will spell out what substances need reporting, how often a sample must be taken and what readings should be reported, for example average or maximum. Even if there is no discharge during a reporting period a DMR documenting that fact may need to be submitted.

It is important to keep good records to document any procedures. The permit specifies in detail what kinds of information must be documented including the laboratory results for samples, a copy of the permit and

Smart Growth Coordinator.

In addition, the governor introduced legislation that creates a new Community Legacy Program in the state's Department of Housing and Community Development. This program will provide financial assistance to communities, thereby revitalizing neighborhoods and encouraging redevelopment of designated brownfields and other infill projects.

"Community Legacy provides funds for critical projects in neighborhoods that can turn a neighborhood on the brink around and that are often not eligible for other funding assistance," Wilson said.

In an effort to complement existing water quality programs as well as land preservation programs, HB 1379 will create the Maryland GreenPrint Program. This program will create a statewide green infrastructure network by acquiring property and property interests including easements. The program, which will operate under the Department of Natural Resources, will allow DNR to use 25 percent of the funds to purchase land in Maryland

Agricultural Land Preservation Foundation-approved districts, in addition to an estimated \$30 million in bonds from the state's fiscal year 2002 budget and more than \$5.8 million in general funds.

The Income Tax Credit for Green Buildings, established under HB 8 and Senate Bill (SB) 745, provide state income tax credits for specific construction and rehabilitation costs of "green whole building" as an incentive for developers and builders to meet all applicable energy efficiency and environmental standards.

House Bill 1163, a piece of lead poisoning prevention legislation, will require medical laboratories to report the home addresses of patients diagnosed with lead in their systems. Bill supporters say they hope this bill will improve MDE's ability to track the locations of lead-poisoned children since having a home address is crucial to identifying areas of the state where children are at risk.

Senate Bill 16 will allow MDE to comply with the reauthorization of the federal Safe Drinking Water Act and

the National Primary Drinking Water Regulations by authorizing the department to impose a graduated penalty system against public water systems when drinking water standards are violated. The maximum penalty MDE can administer is based on the number of Marylanders served by the specific water supply.

"This bill will help ensure that all public water systems in Maryland comply with safe drinking water standards," said James L. Hearn, director of MDE's Water Management Administration.

Mercury thermometers, which at one time were a staple of every school nurse's office, will no longer be available for purchase in Maryland after the passage of HB 75. The bill, with some exceptions, will prohibit manufacturers from selling or providing fever thermometers containing mercury to a consumer as of Oct. 1, 2002. Mercury-based fever thermometers may only be purchased with a prescription and all primary and secondary schools in the state will be prohibited from purchasing the thermometers after Oct. 1, 2003.

"This legislation represents and important step in reducing the amount of mercury released into the environment and establishes an education and outreach program that is critical to the success of a mercury reduction program," said Rick Collins, director of MDE's Waste Management Administration.

The General Assembly also passed SB 117, which authorizes the Public Service Commission (PSC) to act on behalf of the U.S. Department of Transportation (USDOT) to implement the federal Hazardous Liquid Pipeline Act. The PSC will establish safety regulations applicable to design, construction, operation and maintenance of intrastate oil pipelines, as well as make periodic inspections of the pipelines.

Finally the governor signed an Executive Order creating the Task Force on Upgrading Sewerage Systems. The task force will identify the costs associated with upgrading state's aging sewer systems, installing biological nutrient reduction technology and make recommendations on how these upgrades will be funded.

MDE addresses EPA's change in toxic inventory reporting

With final reports due by July 1, facilities nationwide and in Maryland are now in the midst of the 2000 Toxic Release Inventory (TRI) reporting season. But perhaps the greatest challenge during this reporting year is complying with significant changes the Environmental Protection Agency (EPA) made to reporting requirements.

Effective with the 2000 TRI reports, EPA changed the thresholds used to determine if a facility must submit a TRI report to the EPA and the Maryland Department of the Environment (MDE). While the new rules affect only 18 of 644 chemicals and chemical compounds covered by TRI, officials from MDE and EPA are expecting a noticeable increase in the number of reporting facilities. And data collected as a result of the new requirements will help MDE in tracking the amount of targeted toxic substances released into the environment annually.

The targeted chemicals, which are persistent bioaccumulative toxic substances or PBTs, are not easily destroyed and eventually become part of the food chain, remaining in the environment for a long time. PBTs have a tendency to build up in plants and body tissues, many are known to cause cancer. And for the first time, new TRI regulations will allow federal and state environmental agencies to track chemical specific PBT release data.

EPA officials said they chose TRI for obtaining industry reports on PBTs because it is a well-established program of chemical release data collection and dissemination.

TRI is in Section 313 of the Emergency Planning and Community Right-to-Know Act (EPCRA). Much of EPCRA is concerned with emergency planning, reporting of accidental releases, and community-access to information about materials on hand at facilities. TRI deals with reporting chemical releases to federal and state governments and making that data readily available to the public. Releases reported under TRI are not just one-time accidents but cover everyday, often permitted, discharges that occur as a normal part of facility operations.

To make TRI an effective tool for collection, analysis and dissemination of information about toxic chemicals, EPA has made frequent changes to reporting requirements. The result is a list of covered industries that has expanded from the original manufacturing facilities to incorporate federal facilities and seven non-manufacturing sectors. The seven new sectors provide support to manufacturing operations and include electricity generation, chemical wholesalers and petroleum bulk terminals.

Over the last 12 years, the TRI chemical list has grown from more than 300 to 644 toxic chemicals and chemical compounds. Most substances affected by the PBT rule have been on the TRI chemical list since 1987, the first reporting year. However, due to high reporting thresholds little information has been collected. Until now, TRI thresholds have been 25,000 pounds for manufacture or processing and 10,000 pounds for other uses of a listed chemical. EPA set the thresholds for the PBT chemi-

cals very low, basing them on characteristics of the specific chemical. Depending on the substance, PBT thresholds are 100 pounds a year, 10 pounds a year, or 0.1 gram a year for Dioxin and Dioxin-like compounds.

Six of the PBTs (pesticides aldrin, methoxychlor, pendimethalin, trifluralin and aromatics tetrabromobisphenol A and polycyclic aromatic compounds category [PAC]) were listed at the 100 pounds year level. Eleven substances (pesticides chlordane, heptachlor, isodrin, toxaphene; aromatics benzo(g,h,I)perylene, hexachlorobenzene, octachlorostyrene, pentachlorobenzene, polychlorinated biphenyls (PCB); and metals mercury, and mercury compounds) were listed at 10 pounds per year.

Many of the PBT substances are aromatics, which means they are contained in fuels such as oil, coal and natural gas. With thresholds set at these very low levels, it won't take much for a facility processing any PBT chemicals to exceed a threshold for one or more of these substances. With fines for failing to report set at \$27,500 a day, it is important for these borderline facilities to examine their activities carefully.

An underlying purpose for TRI was to provide information to enable the public to identify environmental concerns so they can work with industry and government to reduce toxic chemical releases and their associated risks, according to EPA Administrator Christie Todd Whitman

"We found out that the more information we have and make available about toxic releases,

the more emissions have been reduced," she said of TRIs.

A recent EPA press release announcing 1999's TRI data, notes a 46 percent decrease (about 1.5 billion pounds) in reported releases from manufacturing facilities since 1987, the first TRI reporting year. An examination of EPA data for Maryland shows a 53 percent decrease, about 9.5 million pounds.

The new rule will provide EPA and MDE with valuable information about these known toxic chemicals. Because the data is collected annually it can be used to track trends in the releases of these substances. MDE can use the data to benchmark quantities when preparing Total Maximum Daily Loads (TMDL) for impaired waterways and the data can also be used to determine if sources of PBT emissions are located close to drinking water supplies or could be negatively impacting livestock grazing lands. MDE officials are also able to review the PBT release data from other states to assess if mercury releases from an electric power plant in Ohio are impacting air quality in Maryland.



ments related to the investigation or remediation of controlled hazardous substances at the property. On the other hand, the certificate is issued upon successful completion of the provisions of an approved response action plan. The liability release provided by the department's signoff enables a current or prospective property owner to successfully market a property or secures financing to redevelop the site.

"MDE's VCP will be working closely with the Port Administration to oversee the remediation of environmental concerns that have resulted from the long history of shipbuilding, ship maintenance, and ship dismantling activities," Miller stated.

In addition to the removal of controlled hazardous substances under the VCP, the Port Administration will be removing and scrapping several abandoned barges and small ships.

"The former Kurt Iron & Metal site is a perfect example of a brownfield site being identified and the land being put back into productive use," said Karl Kalbacher, director of MDE's Environmental Restoration and Redevelopment Program. "The port is to be commended for taking the initiative to move forward. This project fits well into Maryland's smart growth strategy of re-using land in our urban centers where infrastructure is already in place, saving taxpayer dollars, while simultaneously stimulating economic development in an existing community."

The Port Administration expects to complete associated cleanup of the site, construct the new facility and begin operations by 2003.

Clean Water Needs Survey is underway across the nation

The Maryland Department of the Environment (MDE) is conducting the 2000 Clean Water Needs Survey (CWNS) to document the needs for sewerage facilities, including sewer and combined sewer overflow abatement/elimination needs, stormwater facilities or nonpoint source pollution controls in Maryland, which existed prior to Jan. 1, 2000.

The Environmental Protection Agency (EPA) requires that all water pollution control needs of counties and municipalities be properly documented and well represented in the survey. The survey provides EPA with a detailed estimate of the funds needed in Maryland and across the country for activities necessary to comply with the requirements of the

Clean Water Act.

"This is an opportunity for local governments and other state departments to report their water quality and public health-related facilities and improvement needs," said Virginia Kearney, acting deputy director of MDE's Water Management Administration. "The data local governments and other state departments provide has a direct impact on the federal dollars that Maryland receives for state and local water pollution control activities. Future federal allocations of capital funding to Maryland and local jurisdictions will depend on how well these needs are documented."

EPA extended the deadline for submission from February until September. MDE has been seeking assistance from local governments and the Maryland Departments of Natural Re-

sources and Agriculture in the collection of information regarding water quality capital project needs in Maryland as part of the survey.

Before 1992, the needs survey focused on publicly owned wastewater treatment works and wastewater conveyance systems. The survey's focus has been dramatically broadened since then, and now reflects evolving funding opportunities under the State Revolving Fund (SRF) program.

For instance, urban storm water, agricultural and silvicultural Non Point Source (NPS) pollution control projects have been added.

In the past, few states have systematically documented their NPS needs using the CWNS, even though a large part of the nation's water quality problem is attributable to NPS. The 2000 CWNS goes way beyond this focus. Even

more NPS categories have been added, including projects for nutrient management, animal waste storage facilities, pre-harvest planning, streamside buffers, road management, erosion and sediment controls, groundwater protection, boating and marina activities, mining and quarrying activities and streambank and shoreline erosion, just to name a few.

A new database, which provides tremendous flexibility to enter and report cost and technical data about a wide range of "facilities" from traditional wastewater treatment, to the development and implementation of NPS pollution projects, has been developed.

For each proposed project, states are required to show both the existences of the need, and the cost necessary to satisfy that need.

copies of the DMRs that have been submitted. Make sure the laboratory used to analyze the samples uses the analysis method specified in the permit. Also make sure the analysis shows any other information the permit may require such as the date and time of the analysis.

The general discharge permit for industrial storm water includes more narrative requirements than other discharge permits, so it is important to read the entire permit. The general permit requires the development of a stormwater pollution prevention plan. The requirements of this plan are spelled out in the permit and an inspector will want to review the plan when the facility is inspected.

Permits can be complicated documents. Contact the Environmental Permits Service Center at (410) 631 3772 with any questions about the requirements contained in a specific permit. A representative of EPSC is also available to meet with you to discuss the requirements of a discharge permit. In addition, the Pollution Prevention program, also at (410) 631-3772, may be able to help a facility to reduce the amount of water being discharged or improve the quality of the water.


