

# Important Information About Your Drinking Water

We're pleased to present to you the Annual Water Quality Report for 2016. This report is designed to inform you about the water quality and services we deliver to you every day. Maryland Environmental Service (MES), an Agency of the State of Maryland, operates the water treatment facility and prepared this report on behalf of Cheltenham Youth Facility.

The Environmental Protection Agency (EPA) regulates Public Water Systems and the contaminants found in water through the implementation of the Safe Drinking Water Act (SDWA). The SDWA sets regulations and guidelines for how public water systems operate and identifies several hundred drinking water contaminants, establishes monitoring frequencies and limitations. The Maryland Department of the Environment (MDE) is responsible for the enforcement of the SDWA and routinely complete Sanitary Surveys as part of their ongoing inspection and monitoring program. MES provides safe dependable operations of the water system and is dedicated to consistently providing high quality drinking water that meets or exceeds the SDWA standards.

The water for Cheltenham Youth Facility water works consists of two drilled wells in the Magothy aquifer, a treatment facility, a 250,000 gallon elevated water storage tank and a distribution network. The treatment facility consist of a chemical feed facility designed to disinfect the water. The Maryland Department of the Environment has performed an assessment of the source water. ## Cheltenham Youth Facility Treated Water Quality Report 2016

### **Definitions:**

- ♦ Maximum Contaminant Level Goal (MCLG) The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ◆ Maximum Contaminant Level (MCL) The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- ◆ **Action Level** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow
- ◆ Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water
- ◆ **Turbidity** Relates to a condition where suspended particles are present in the water. Turbidity measurements are a way to describe the level of "cloudiness" of the water.
- ◆ pCi/l Picocuries per liter. A measure of radiation.
- ppb parts per billion or micrograms per liter
- ◆ ppm parts per million or milligrams per liter

### **Lead Prevention**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Cheltenham Youth Facility is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. The table above lists all the drinking water contaminants that were detected during the 2016 calendar year. The presence of these compounds in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in the table is from testing done January 1 – December 31, 2016. The State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year.

## Sources of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases radioactive material, and can pick up substances resulting from the presence of animals or from

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain compounds in water provided by public water systems. We treat our water according to EPA's regulations. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.



### Important information Regarding Gross Alpha Emitters:

Alpha emitters are naturally occurring radiations in soil, air and water. These emitters generally occur when certain elements decay or break down in the environment. The emitters enter drinking water through various methods including the erosion of natural deposits. There are no immediate health risks from consuming water that contains gross alpha, however some people who drink water containing alpha emitters in excess of the MCL over many years may have an increased risk of getting cancer. Currently, the highest level of gross alpha detected is 2.1 pCi/L which is below the 15 pCi/L MCL.

## Water Conservation Tips

- ♦ Check for water leaks by the reading your water meter before and after a two hour period when no water is being used in your home. If the reading changes then there is probably a leak in your home.
- ♦ Take a shower! Filling up a bathtub can use up to 70 gallons of water while a shower generally uses 10 to 25 gallons. Taking shorter showers saves even more water.
- ♦ Make sure your washing machine and dishwasher are fully loaded before running.
