Minutes

1. Introduction by Camille Burke, Chair

Camille Burke welcomed the commission and Introduced our new Commissioner, Lori Cunningham. She works in community outreach for the City of Bowie and is representing MML on the Commission. Lori Cunningham shared that she works on diversity education, public art, and community outreach programs. She is excited to learn and contribute to the Commission.

Camille Burke shared that it is National Childhood Lead Poison Prevention Week. As part of her day job she participated in a kickoff to celebrate the week of awareness. This was in College Park with MDE & MCHD. Horacio Tablada was also there and he shared that it was a great program with all of the partners including Green House and Healthy Homes.

Camille Burke asked commissioners to watch for an email on minutes that need to be approved and a draft of the annual report recommendations. More to come on this in the meeting.

2. **CEJSC Appointments Update**

Devon Dodson shared that MML, MACo, and the AFL CIO have made their appointments. The Governor has one appointment left for a university with an EJ program. The rest of the appointments are with the presiding officers and have been for the past year. He has reached out a few times over the year. This accounts for more than a quarter of the membership of the commission. Delegate Boyce mentioned that the presiding officers are focused on the election this year. The Commission agreed to write a letter to the presiding officers asking them to fill these positions.

3. Staff Update: MDE EJScreen

Devon Dodson updated the Commission on MDE EJScreen. For those unfamiliar, in 2021 the internal workgroup at MDE decided to develop a screening tool. The great news is it is up and running and the MDE staff understands the tool and understands the value.

Under HB 1200, applicants for MDE's public participation permits have to provide an EJ score to MDE, using an EJ tool. MDE confirms the score and it is shared with the community. This is the basics of the law, but MDE wants to do more. There is no provision allowing MDE to deny the permit based on the score. Practically, MDE can review the score and look at the need for any additional conditions or modifications based on the score and community concerns.

Another tool in the toolbox is the overburden/underserved definitions passed in the CSNA this year. Devon Dodson has also met with MDOT, MDP, MDH, and DNR who are all also using the tool for their own programs/purposes.

Camille Burke said that she understands MDE can't deny a permit, but can you delay based on the score? Devon Dodson answered yes, we delay permits all the time. That is not unusual, especially if a community has not been engaged or if they are in ongoing conversations with the regulated entity.

Secretary Tablada said that MDE always considers the community point of view and we work to get more information and give consideration to their concerns. This happened recently with an issue on the shore and ultimately the application was withdrawn.

MDE is continuing to grow the screening tool

John Papagni asked about what is a public participation permit. Devon Dodson answered it is a permit application that requires public notice and comment in the law. An example of something that does not is a permit for dental radiation machines.

Pete Hill asked if the mapping tool has an urban focus or if rural areas are included. Devon Dodson answered that the tool covers both. Pete Hill asked if there is access to county information. Yes, the socioeconomic information is the same and if there are facilities permitted by MDE, they will be on the map as well.

4. Discussion: Justice 40 Initiative

Devon Dodson began the discussion on Justice 40 to address how the conversation about this effort is happening on the state level. Seventy-three of EPA's programs are covered under Justice40 which includes pretty much every program MDE receives funding from. The policy says 40% of these funds should be spent in underserved or overburdened communities. EPA is definitely giving money to the states to operate things like clean water drinking, infrastructure divisions, etc. They are using MDE Screening Tools to do that. This year's State budget has language that mirrors the Justice 40 funding language.

Devon Dodson and other staff have met with Region III and with EPA headquarters about this to give feedback. Region III is working with communities. They shared with us who they have picked for outreach. The list includes Port Towns, which is next to Cheverly who we have worked with, Cherry Hill, next to Curtis Bay, Hopkins-Middle East, and Sparrows Point, next to Turner Station. Since these are all next to areas we are working in, Devon Dodson asked if it is possible to look at not just these four but use a cluster approach. Just this morning, he got an email back saying yes we will explore this concept.

The bulk of the money will be coming in 2023. This will likely get bigger and bigger. There will be opportunities for the Commission to do outreach, help identify communities, and make sure the right communities are being addressed.

Dr. Wilson added to the discussion. He is an ex officio member of NEJAC. The NEJAC developed a group to give feedback to the EPA - \$3 budget - probably more than ever had for EJ before. He thinks it is important to be tracking who is getting the money, who is applying, and what the return on Investment for that money is. He mentioned that there is a New White House Environmental Advisory Council (WHEJAC) that serves as an overarching body for all federal agencies. Many of the federal offices now have offices of EJ, but the NEJAC was there for 40 years. He thought that we could create some sort of tracking method for the state agencies and he mentioned the budget language too. He said we need to think about restorative justice and what are we going to do about that, thinking about how EJ has affected multiple generations.

Devon Dodson mentioned that DOE has created an EJ office and anytime a federal agency creates something, it is expected to go to the states. MEA is already required to give % of funds to the EJ communities and they too are using the screening tool.

Camille Burke has a comment and question. EPA mentioned four communities, but none on the shore or out west where there are well documented EJ issues. Please mention that to the EPA. Devon Dodson said he did mention this to the EPA Region III Administrator. This is just the first phase, they believe they will do more in further reaches of the state. Camille Burke continued that these dollars are very prescriptive - communities will need to understand what these dollars are for, not just for spending

Subha Chandar commented that we have heard a lot today and there is a lot involved. Devon Dodson said he is also trying to figure it out. The Commission could be required to do certain things, working in consultation with MDE and he hopes with more appointed members, we will have more capacity. The best we can do is keep gathering information, follow what's happening, make sure not so prescriptive that we can't get the money to the communities. Devon Dodson agreed and mentioned that he only meets with NGOs if they have a community involved with them. He also predicts EJ officers for additional agencies. Dr. Wilson said this is in the scorecard recommendations too and he expects MDE to get an A next year with all of the efforts the Department is making.

Mayor Noah Wilson of Eagle Harbor spoke up to describe some of the issues the town has been dealing with in terms of Pepco. There is a power plant next door and he would like a sunset, green technology, restoration to the community for the Environmental injustices. Devon Dodson said that he knows MDE's WSA program has been in touch and asked the Mayor to please outline these issues and share directly with him as the EJ officer. He will look at what we are doing/not doing and be able to understand who is responsible. Camille Burke thanked the Mayor and invited him back. Please keep us up to date with what is going on. Our role here is to hold agencies' feet to the fire on these issues. If we don't know about it, we can't help you. The Mayor mentioned an on site meeting on November 5th, Saturday at 1p with the community and university partners. He will share that information.

5. Discussion: Annual Report

Devon Dodson will email the draft recommendations for the Commission to review. They are set up with the statutory requirements in italics and a recommendation for each requirement. The draft recommendations are based on the conversations we have had about these various issues over the year. Devon Dodson reviewed the draft quickly and asked everyone to please write back if you support, don't support, or need edits. This was due October 15th so please send comments by the end of next week.

6. Public Comment

Rebecca Rehr, LCV, appreciates the recommendations for next year and that they include some CSNA implementation. She reminded the group that the law says or before 2023 so we may want to

move ahead with some things ooner. If anything we (advocates) can do to be supportive, please let us know.

Kamita Gray said that we have important community organizations that deserve a place at the table and they are very capable people. Devon fully understands, if still want to do presentation at the next meeting, that is possible

Monica Brooks commented that some people who have been at the table a long time and have access, are known, etc they know where to go, but there are other people who are not aware and we are in a good position to influence and make sure everyone can see how to make access. We need to work to chip away at some parts of the conversation that need to be removed. For example, often people group minority and low income, but they are not necessarily related. Yes, Devon said unconscious bias training can be important.

Devon Dodson mentioned that the next meeting is scheduled for Tuesday, November 22nd and we also have a meeting a week or two later with CEHPAC. He is leaving up to the commission if we should have two meetings. Delegate Boyce suggested waiting for the December meeting and Camille, Burke agreed. We have exceeded the number required by law. Due to COVID, we have not met the outreach part since we have held off on in person meetings. We do hope to begin in person or hybrid meetings in the spring. Perhaps we will start with Eagle Harbor. Camille Burke asked that we come with a schedule for 2023 where to go, what to do, etc. Delegate Boyce do field trips have to be on the day of the meeting? No, we have tried do it some because dates already on calendars
