Inspection Findings:

Inspection was conducted as a follow-up to this writers December 16, 2021 inspection. This writer notes that there was no discharge at the Outfall 001 location.

This writer inspected the facility's Outfall 001 stream outfall and confluence of the Transquaking River on December 20, 2021 and observed visible white solids. Mr. McEntyre stated that discharge from the facility started on Saturday, December 18, 2021 and stopped on Sunday December 19, 2021. He stated that the discharge was stopped due to evaluated ammonia levels in the discharge. Mr. McEntyre stated that he was not aware of any accumulation of solids in the stream outfall or the confluence of the Tranquaking River.

This writer advised Mr. McEntyre that this writers December 16, 2021 inspection documented proper cleanup of the December 15, 2021 sludge spill in the stream outfall and Ms. Kennedy's December 17, 2021 inspection documented proper cleanup of the December 15, 2021 sludge spill at the confluence of the Transquaking River. Mr. McEntyre was advised that the accumulation of solids must have been a result of the discharge that occurred at Outfall 001 on the December 18 and 19, 2021. He was then advised by this writer December 20, 2021 to take immediate action to properly remove and dispose of the solids in the facility's stream outfall and confluence of the Transquaking River. This writer notes that Mr. McEntyre then contacted CES, Chesapeake Environmental Services to initiate the cleanup operation. Inspection showed that shortly after Mr. McEntyre contacted CES representatives arrived on site and began to remove the solids from the stream outfall and confluence of the Transquaking River. This writer advised Mr. McEntyre to report the incident to MDE.

Reinspection of the facility on December 21, 2021 showed that the white solids at the confluence of the Transquaking River had been removed. This writer notes that the remaining portion of the white solids in the stream outfall was removed during the inspection. Mr. McEntyre stated that he is currently recirculating the facility's wastewater through the treatment processes in preparation to discharge at the Outfall 001 location.

Inspection at the #1 wastewater lagoon shows that it has about 8 inches of freeboard with the #2 wastewater lagoon having about 10 inches of freeboard. This writer notes that wastewater from the treatment lagoons was being hauled off site by tank truck. Eight of the ten mechanical aerators were in operation at the #1 lagoon. Further inspection of the #2 lagoon shows that the scum layer covers approximately 25 % of the lagoon surface. Inspection around the perimeter of the lagoons did not reveal any offensive odors. Mr. McEntyre is requested to provide the waste hauling manifests for the cleanup at the stream outfall, confluence of the Transquaking and pump out of the lagoons.

Corrective Actions

Mr. Bledsoe is hereby advised to immediately cease any and all unauthorized discharges, including discharges in violation of the Permit. He shall take any or all of the following actions to ensure proper operation of the WWTP including:

- 1.Immediately begin pumping and hauling all wastewater as necessary in order to maintain 2 ft of freeboard in lagoons #1 and #2;
- 2. Immediately cease operations as necessary to eliminate generating any additional wastewater until such time that the discharge is in compliance with the permit effluent limits and the facility is able to consistently maintain 2-ft of freeboard;
- 3. Immediately ensure that a certified operator is at the facility and overseeing the operations at all times when the facility is discharging;

4. Within ten (10) days, retain the services of a certified engineer to conduct an evaluation of the treatment system to provide improvements/recommendations to the operation of the WWTP to ensure compliance with the permit. Notify the Department of the name and address of the certified engineer. Within sixty (60) days, have the certified engineer complete the evaluation of the WWTP. Provide a final report from the certified operator to the Department within thirty (30) days upon completion of the evaluation;

- 5. Immediately maximize the operation and maintenance of the wastewater treatment plant to comply with the discharge permit;
- 6.Perform visual inspections of the facility as necessary to ensure compliance with permit discharging, including walking along the stream outfall for Outfall 001 to the confluence of the discharge with the Transquaking River to identify adverse impacts including excess solids, discoloration, or other evidence of unauthorized discharge. When discharging, these inspections should occur at least hourly and shall be documented and records maintained for review by the Department. The inspection reports shall include the date, time, name of the inspector, and any observations recorded.

Valley Proteins shall notify the Department for all of the following:

- 1. At least two (2) hours prior to restarting discharging and immediately upon stopping discharging.
- 2. Immediately upon an unauthorized discharge.
- 3. Within one (1) hour of starting pumping and hauling operations.

Failure to comply with any of the actions listed above may result in the Department taking additional actions, including but not limited to issuing an Administrative Order, suspension of the permit, and/or administrative and civil penalties.

Valley Proteins shall notify the Department by 12:00 pm, Wednesday, December 22, 2021 whether the facility has returned to compliance with all permit conditions and how the facility intends to ensure that future operations will comply with discharge limits and the terms of the permit.
