1. Cumulative Impacts

<u>Charles Lee - Environmental Justice Pioneer</u>

- Charles opened by noting the importance of assessing cumulative impacts on human health and the environment and particularly in marginalized communities. Also, the importance of centering this work in improving both human health quality and the environment. Existing screening tools were mentioned as a helpful assessment tool.
- The challenges of introducing cumulative impacts legislation were also discussed, and the intersection of environmental justice and cumulative impact analysis was highlighted.
- Finally, the need for a more innovative approach to address cumulative impacts was emphasized, along with the importance of building capacity for community engagement and advocacy.
- Charles highlighted the need for data-driven decisions in the environmental justice space.

- He emphasized the importance of combining quantitative and qualitative methods to capture the lived experience of communities in a robust and authentic way.
- Charles discussed EPA's evolving cumulative impact framework, with a focus on collaboration and collective learning.
- He expressed the importance of and need to invest in more discussion and tease out the complex issues related to cumulative impacts.

Questions and Comments

- There was a discussion about the challenges of addressing cumulative impacts in Maryland, including political resistance and the need for more conversations.
- Suggestion proposed that the term "cumulative impacts" should be operationalized to address multiple burdens and stresses.
- Assistant Secretary of Just Communities, Cat Goughnour, discussed environmental justice and health impact assessments.
- Need to enhance the capacity of technical assistance centers to address queries and offer support to marginalized communities.
- The use of maps was suggested to identify areas with cumulative impacts.

2. Public Comment

- General discussion by Commissioners and members of the public related to
 environmental justice and health equity in Maryland, emphasizing the importance of
 community engagement, data-driven approaches, and inclusive decision-making
 processes. Speakers highlighted the need for a comprehensive and holistic approach to
 addressing environmental issues, prioritizing the voices and needs of marginalized
 communities. Comments also stressed the importance of operationalizing legislation to
 focus on racial equity and social justice, and of strategic planning to ensure the
 commission stays on track.
 - Schedule strategic planning session for commission.
 - Commissioner Gaither shared updates on upcoming events in Curtis Bay.
 - Commissioners and general public to provide feedback on enhancing EJSCREEN tool to better capture structural racism indicators.
 - The Environmental Justice and Health Disparities Symposium on environmental justice and climate justice issues will take place on September 11-14, with commission members encouraged to attend.
 - Dr. Wilson discussed the Commission's decision on a dedicated panel, suggesting alternative ways to involve the Commission in the symposium if decided not to have a separate panel.
 - Commissioners discussed sharing emails for exchange of ideas between

meetings.

- Commission members encouraged each other to enhance the feedback loop between state agencies and the commission.
- Commissioners emphasized the importance of tracking measurable outcomes to ensure environmental justice.
- Speakers emphasized the importance of environmental justice and community involvement in decision-making processes.
- It is suggested that the term "environmental justice" should be used more holistically and inclusively, rather than narrowly focused on impacts analysis and permitting.
