*We use compostable cups for wine service, compostable utensils, plates, etc. for all catering that we have aboard through our caterer, Palate Pleasers.*

*We save about \$150 a year by reusing paper instead of purchasing new notepads.*

*We recycle all the paper and cardboard that we use aboard and in the office. There are no cost savings, since we have to pay for recycling.*

**Energy Efficiency**

*Aboard our boats and in our offices we have upgraded to efficient LED lights. Aboard the boats, we are very conscious of how much electricity we are using so we don't overload our systems. We also use an Ecobee smart thermostat that we can manage when no one is working in the office or if they leave early. This has saved us approximately \$450 annually over having a non-smart thermostat.*

**Renewable Energy**

*We buy 100% Wind Power from WGL. It costs us more, but we like knowing that it comes from the wind.*

**Employee Commute/Customer Travel**

*We always carpool wherever our staff needs to travel somewhere.*

**Fleet of Sailboats**

*We just installed two new engines on our schooners that release much less emissions, (35% less than our older diesel engines). We also try to use wind power as much as we can. Our fuel reports were 10% less when we made this an initiative to be "Green." We are proud of this!*
