**Environmentally Preferable Purchasing**

*We purchase locally grown produce and non-phosphate, non-toxic and biodegradable laundry soap.*

**Environmental Restoration or Community Environmental Projects**

*In their Old Town Laurel neighborhood, Lisa and Dave Everett have hosted and participated in neighborhood litter clean-up parties, and were recognized for these efforts from the Laurel City Council. Additionally, the Everetts have planted more than a dozen trees on the .9-acre property.*

## Waste

**Solid Waste Reduction and Reuse**

*In the spring of 2011, Lisa and Dave Everett purchased the house at 1110 Montgomery Street in Laurel, Maryland with the goal of transforming it into a bed-and-breakfast. During seven years of renovating and rebuilding, the Everetts carefully removed doors, hardware, and trim boards, then reused these original materials, or purchased salvaged building materials to the greatest extent practical. Additionally, the Everetts donated unwanted materials, such as bathroom fixtures and 200 square feet of pine flooring to a nonprofit reuse and salvage center for home improvement supplies.*

*Other waste reduction practices include the use of bulk soap dispensers instead of individual soaps/shampoos/conditioners, cloth napkins, and water pitchers and filtered water to minimize the use of single-use bottles.*

**Composting**

*We use a compost tumbler then use the composted materials for fertilizer.*

## Energy

**Energy Efficiency**

*New fixtures and appliances have been purchased with a goal towards energy efficiency. The home's furnace and air conditioning were replaced with modern, high-efficiency appliances; the water heater is a tankless unit, providing hot water on demand and not using energy at other times; and the washer and dryer are energy- and water-efficient models. The house interior and exterior lighting is primarily LED and compact fluorescent light bulbs.*

*According to the Maryland Department of the Environment impact calculator, Laurel Manor House Bed and Breakfast's use of 26 CFLs and 20 LED light bulbs saves in excess of 2600 kWh per year resulting in a reduction of carbon dioxide emissions of more than 4000 pounds per year.*

## Water

**Water Conservation**

*The home's bathrooms were renovated to include modern, low-flow faucets, shower heads and toilets. We also have signage in each room encouraging guests to reuse towels*

**Stormwater Management and Site Design**

*Landscaping installed on the property includes a patio and driveway pull-off constructed of permeable pavers.*
