Environmentally Preferable Products and Services

Backyard Bounty is a small, woman-owned landscape design, build and maintain firm that specializes is ecological practices, native plants and habitat, specialty masonry and stormwater management.

Backyard Bounty is the leading landscape stormwater management company in Montgomery County having installed more than 200 Rainscapes projects (e.g. rain gardens, conservation landscapes, etc) since our founding. In addition, we have done projects with Prince George's Raincheck Rebate, DC Riversmart, and Arlington County Stormwaterwise programs. - Backyard Bounty gardens are currently preventing more than TWENTY-TWO MILLION GALLONS of stormwater from flowing into the Potomac River each year.
- Backyard Bounty uses at least 75% native plants in our installations, no synthetic fertilizers, no pesticides, and soil-friendly shredded pine mulch.
- Backyard Bounty has recently started repurposing hardscape construction debris into new construction projects through innovative practices such as gabion walls.

Environmental Restoration or Community Environmental Projects

Backyard Bounty participates in multiple community environmental projects including Homegrown National Park, Montgomery County Green Landscapers, Sierra Club of Maryland Pesticide-free campaign, community outreach for the Healthy Lawns Act, Potomac Conservancy Take Me To The River, Eastern Middle School Rain Garden project, Audubon (aka Nature Forward) Woodend Cleanup Day, multiple forums about environmentally sustainable landscaping at garden clubs and organizations, etc.

Backyard Bounty was one of the first landscaping companies to migrate all of our maintenance equipment from gas to battery power now using on average 1.1 kWh of electricity daily in place of the equivalent gasoline.

Backyard Bounty uses multiple all-electric vehicles for our team, replacing 30,000 miles per year of gas-powered travel with electric.

Stormwater Management and Site Design

Backyard Bounty gardens annually prevent 22 million gallons of stormwater from entering storm drains, streams and the Bay.
