*We have certified wetlands and ponds on our property that we maintain in accordance with the Department of Agriculture of Charles County. We ensure that we maintain the property to the standards set at all times through out the year. Our staff follows all of the department's regulations as well as any suggestions they offer to better accommodate for the well being of these wetlands.*

## Waste

### Solid Waste Reduction and Reuse

*Our company does several thousand jobs a year and almost all of them require packing items into corrugated cardboard totes that aren't recycled even after one use. By switching to heavy duty plastic crates, we are able to pack*

*items, move and then reuse them. We estimate that with this practice, we are reducing 8 tons of cardboard waste per year. This amounts to a reduction of 45 metric tons carbon equivalent (MTCO<sub>2</sub>E) in greenhouse gas reductions annually.*

**Hazardous Waste/Toxic Use Reduction**

*Anytime one of our trucks is serviced for an oil change, our mechanics recycle and reuse the motor oil. We have a place on the property outfitted with all necessary items to change the oil and dispose of it properly with specially designed 55 gallon drum tanks*

## Transportation

**Fleet Vehicles**

*In 2009, District Moving Companies purchased and added Smart car vehicles to our fleet lineup for our employees to use whenever traveling for company appointments and or errands.*

## Water

**Stormwater Management and Site Design**

*District has a contract with a local landscaping company to ensure that the property is always properly landscaped and kept up to defined standards. This is not only used to keep the property looking nice, but also to help with any run off from surfaces where our fleet of vehicles is located.*
