### Environmental Team

*Holmatro has a very active Green Team that meets monthly and benefits from a strong commitment from the company's leadership. This team has focused on heightening their culture of energy awareness at the level of the individual, including efforts such as checking thermostat settings, closing blinds in offices on the sunny side of the building, and making sure that production equipment not in use is powered down.*

**Environmentally Preferable Purchasing**

*Holmatro's policy is to consider the environmental impact of all purchasing choices. For example, our cardboard shipping boxes are SFI certified and we purchased EnergyStar computer equipment.*

**Solid Waste Reduction and Reuse**

*Holmatro recycles 100% of its waste in the manufacturing process including all the steel and aluminum chips and bar drops, as well as the motor oils, hydraulic oils and coolants.*

*As part of Holmatro's commitment to creating a culture of sustainability, all the proceeds from these waste reduction efforts go into a fund for the employees that are used throughout the year for Lunches, Family Picnic and Christmas Party. It also allows me to give a monetary reward to an employee for outstanding performance.*

**Recycling**

*Holmatro is committed to recycling beyond their efforts to reduce manufacturing waste. Throughout the facility, recycling has been made easy and clear with signage, containers, flyers and banners.*

**Energy Efficiency**

*Over a five year period, Holmatro has reduced its energy consumption prior to joining the RMI Energy Efficiency program in the spring of 2014.*

*As a result of joining the RMI program, Holmatro committed to making the following upgrades using the Maryland Energy Administration Lawton Loan program: installation of LED Lighting within the 80,000 square feet of factory space; installation of new rooftop units and upgrade controls and installation of de-stratification fans for air purification. Projected annual savings are 525,075 kWh with the upgrades.*

*Holmatro also has a profit sharing plan that encourages and incentivizes energy savings awareness throughout its operations.*
