Our environmental team includes our entire company. We meet weekly to discuss ways for our projects and our company to increase energy efficiency, conserve water, reduce consumption of virgin materials, cut greenhouse gas emissions, and achieve various performance standards (LEED, Green Globes, Living Building Challenge, Baltimore City Green Building Standards, NAHB/NGBS, Energy Star, International Green Building Code, etc.) All employees are, at a minimum, LEED Accredited Professionals; while some hold and maintain multiple green building and sustainability accreditations.

## **Environmentally Preferable Products and Services**

Lorax Partnerships provides green building and sustainability consulting services to developers, building and business owners, architects and other real estate professionals interested in improving the environmental performance of their company, building or development project. Since 2003, Lorax has provided sustainability services for hundreds of projects nationally with a focus in the Mid Atlantic area for building design and construction, existing building performance and operations, and business sustainability practices.

To date, Lorax has obtained a green building certification for 164 projects:

Lorax uses integrated design to achieve highly efficient buildings. To date our projects have saved over 13 million kWh of energy. We also encourage and assist the development and implementation of recycling programs for all of our clients.

We recommend dual flush toilets, waterless urinals, low flow showerheads and bathroom fixtures for improvement in water efficiency. All of our projects achieve at least a 20% water reduction. To date, our projects have saved over 24 million gallons of potable water.
