#### **Environmentally Preferable Products and Services**

*Our company utilizes a dry extraction carpet cleaning process called milliCare®, which offers the following environmental benefits:*

- *Improved indoor air quality in the facility*
- *Use of Green Seal certified cleaning products.*
- *Reduction of landfill waste by extending the useable life of carpet*
- *Energy and water reduction compared to competitive cleaning systems*

#### **Environmentally Preferable Purchasing**

*We purchase our core cleaning chemicals in a very environmentally friendly manner. The packaging for these chemicals is minimal compared to other cleaning products in the industry. For example, highly concentrated tablets are used for our pre-sprays. This greatly reduces the amount of packaging required. They previously were shipped in partially diluted 5-gallon plastic containers and now are shipped in tablet form in a small cardboard box. Plus, the reduction in weight helps with the amount of fuel burned in the transportation process.*

*Also, our milliCare® Dry Carpet Cleaner product is no longer being shipped in large plastic pails. It is now shipped in plastic bags and all of our plastic pails are being completely REUSED! The net impact is a reduction of approximately 2,000 plastic pails on an annual basis.*

### **Recycling**

*We work closely with our trash vendor to make sure that waste from our office is recycled, reused, or disposed in the most responsible manner possible.*

## Energy

### **Energy Efficiency**

*Our proprietary milliCare® carpet cleaning process reduces the amount of energy consumed by over 75% when compared to other competitive, traditional cleaning systems (hot water extraction, etc.). This translates to a reduction of carbon emissions by over 75%.*

## Transportation

### **Fleet Vehicles**

*We have converted several of our fleet vehicles to smaller, more fuel-efficient models in an effort to minimize fuel consumption. This practice will continue every time one of our vehicles reaches the point in which it needs to be replaced per our lease agreements.*
