### Recycling

*We recycle cardboard, scrap metal, office paper and plastic.*

**Hazardous Waste/Toxic Use Reduction**

*By using our Bonny Marlin System<sup>®</sup>, we have reduced our VOC emissions by approximately 35%. We do not have to handle hazardous waste by having our employees recycle or prep for off-site recycling.*

*We also use the BASF Waterborne Paint system for refinishing our customers collision damaged cars. Using this system of water-based paint versus solvent-based paint, we are reducing our paint emissions (measured in lbs of VOCs) by approximately 47% for a calculated savings of 24 lbs per month or 294 lbs per year. The paint is also almost odorless and much more user friendly.*
