Annual Environmental Goals

Environmentally Preferable Procurement

The Hospital has approved an Environmentally Preferred purchasing policy to evaluate environmental impact of all purchasing. 85% of the chemicals utilized by the Environmental Services Department of Union Hospital have been converted to “Green Seal” certified products.

The Food and Nutrition Department of Union Hospital has established the following practices:

- *All foam products have been eliminated and either biodegradable or paper products are utilized.*
- *Whenever possible, “energy star” certified equipment is purchased.*
- *Local, sustainable food sources are utilized.*

The Facilities Department of Union Hospital has had a Maryland Pesticide Network assessment conducted on its pesticide usage throughout the campus. There will be follow-up to this assessment to identify environmentally friendly chemicals that can be utilized in this capacity.

Recycling

The Union Hospital Green Health Initiative has fully implemented a single stream waste recycling program. Currently the hospital recycles cans, glass, plastics, newspaper, cardboard and mixed paper. We also recycle electronic equipment and toner cartridges.

In order to promote a reduction in the volume of municipal waste produced by the hospital, a food waste recycling and food composting program has been fully implemented. Our food waste is being recycled to area farmers for feed for their livestock. We have on site composting to utilize with our landscaping program.

Union hospital has fully implemented an energy conservation (EPA Energy Star) program. All light switches on the hospital campus have been labeled with a sticker stating, "Last One Out, turn it Out" and all hospital employees have been educated on the importance of turning these lights out when it is expected that they will be out for at least four hours.
