## **Management and Leadership**

#### **Environmental Team**

We have a "Green Team" which comprises eight cross-functional staff persons. We meet a minimum of quarterly, and constantly try to find additional ways to conserve resources and communicate to staff.

## Annual Environmental Goals

In our meetings, we review our progress against other best practices, and attempt to come up with new goals. If we feel we are currently performing best practices, we shift our goals to communication to staff concerning what they can do individually and at home.

## **Environmentally Preferable Purchasing**

In our purchasing, all things being equal, preference is given to environmentally responsible vendors. This applies to print vendors, paper (we purchase Forest Stewardship Council (FSC) certified papers), copy and fax machines, computers, and small office equipment. We recently purchased a printer with a high environmental rating, and the decision was largely based on that consideration.

## **Environmentally Preferable Products and Services**

We offer the option of electronic pledging rather than using a paper pledge form.

Sometimes as part of our sponsored "Days of Caring" we are involved in clean up of local communities and natural environments. Since we are a nonprofit, part of our mission is the improvement of life for the local community, which includes a clean environment

#### Solid Waste Reduction

By using electronic pledge forms rather than paper, we have reduced the volume of our printed material by at least 5,000 pounds yearly. We also limit the overall volume of printed information.
