Name: The Honorable Kathryn Fry Hester **Organization:** Maryland State Senate

Title: Maryland State Senator, Democrat, District 9, Howard County and Montgomery County

Seat: A member of the State Senate, appointed by the President of the Senate

Personal Background: Senator Katie Fry Hester has represented Maryland's 9th district since 2019 and serves as the Deputy Majority Whip. She is the Senate Chair of the Joint Committee on Cybersecurity, Information Technology and Biotechnology, as well as a member of the Joint Audit and Evaluation Committee, Joint Committee on Legislative Ethics, and Women Legislators of Maryland. Additionally, she is a member of the Committee on Education, Energy, and the Environment, and its subcommittees on energy and environment. In addition to her work in the Senate, Senator Hester is a Maryland First Responder and volunteers with the Wisp Ski patrol.

Organizational Background: The Maryland State Senate is the upper house of the General Assembly, the state legislature of the U.S. state of Maryland. There are 47 senators, one from each of Maryland's legislative districts. The Senate Chamber is in the Maryland State House on State Circle in Annapolis.

Name: The Honorable Lorig Charkoudian **Organization:** Maryland House of Delegates

Title: Maryland State Delegate, Democrat, District 20, Montgomery County

Seat: A member of the House of Delegates, appointed by the Speaker of the House

Personal Background: Lorig Charkoudian is a Maryland State Delegate representing the 20th District, along with Del. Moon and Del. Wilkins. She assumed office in 2019, and has since been serving on the Economic Matters Committee. Del. Charkoudian also serves on the Public Utilities Subcommittee. In addition to her work in the House of Delegates, Del. Charkoudian participates annually in a fundraising campaign for mediation programs between families and prisoners.

Organizational Background: The Maryland House of Delegates is the lower house of the legislature of the U.S. state of Maryland. It consists of 141 delegates elected from 47 districts. The House of Delegates Chamber is in the Maryland State House on State Circle in Annapolis.
