# Draft 2022 Work Plan:

The ECO work plan requires collaboration from the Climate Commission's other working groups to increase capacity to coordinate and facilitate education, communications, and outreach to Maryland's racially and ethnically diverse constituencies. All materials produced on behalf of the Commission and its working groups intended for public consumption should be coordinated by ECO. This serves as the overall public relations plan for the Commission in 2022.

Overall, the Commission's big issue this year is **transportation**. We should think about ways we can help move the ball forward for EVs and other transportation programs that aim to reduce emissions. With whom should we partner/collaborate?

In order to accomplish our goals, ECO needs to add new members and specifically, a few folks with graphics design and digital media skills.

Ideas for projects will plug into one of these three areas:

#### **EDUCATION**

#### Ideas:

Identify and support climate change education at schools and universities. Create a climate Change dashboard of issues for the website like the United Nations has. Support MDE's annual Sculpture Contest Climate Academy participation (Commission speaker)

#### **COMMUNICATIONS**

ECO leadership and members are available to all working groups to provide ECO guidance and/or assistance. In turn, it is important that the other working groups come to ECO with special public-facing project ideas to plan the marketing and communication facilitation of the projects.

#### Ideas:

Develop graphics and materials that identify key messages on climate change that highlight the Commission's work and the state's standing as a CC leader among states. Create a one-minute video introduction of the MCCC.

- Jody Couser's idea Jill Lemke, Port of Baltimore:

Background: Port of Baltimore Climate Change Strategy Highlighted at COP26 This fall, the global priority of fighting climate change brought together almost 200 nations for the 2021 United Nations Climate Change Conference, also known as COP26. One of the conference presentations provided world leaders the opportunity to learn about the Port of Baltimore's innovative efforts to address the impacts of a changing climate. Conference organizers stated, "Ports, like other forms of transport infrastructure, are potentially vulnerable to the effects of the changing climate, particularly extreme weather. Therefore, it is critical – not just for ports themselves but also for the economies they support – that the sector is well-prepared for climate change." Maryland Department of Transportation Maryland Port Administration (MDOT MPA) Manager of Strategic Planning and Special Projects Jill Lemke, one of the agency's leading climate change experts, provided a virtual presentation on MDOT MPA's strategy. "It was an honor to represent Baltimore and describe what we are doing to become a more climate-resilient port at what can be considered the Super Bowl of climate change. I look forward to applying some of the principles discussed during the sessions here in Baltimore. Although each port may face very different challenges, there are plenty of similarities to learn from," said Lemke.

#### **OUTREACH**

ECO will work with the CJ team to set up a series of meetings with community leaders. Emphasis will be placed on those communities identified as most vulnerable to climate change impacts. (Using MDE's new EJ tool.) CJ will be included in all community leader meetings. Jody has reached out to Greenmount Community leaders in Baltimore.

Let's discuss how to reach out to local governments on a consistent basis, make relationships, understand what programs and policies that counties and municipalities are advocating and implementing. How can we best work together?

Set up a mini-speakers bureau as referenced above – begin with leadership (nine MCCC members), rotating their participation at events speaking on behalf of MCCC, using a Powerpoint presentation that ECO will produce. (Comms folks)
