- Recognition of Climate Change Activity Outside State Government
  - Climate champions is expanding. Phase 2 will focus on developing climate knowledge in industry and phase 3 will focus on developing climate champions in the university system.
  - Want to develop more recognition for the climate champions throughout Maryland
