- Applications are processed on a first-come, first-served basis. You cannot reserve a space by phone. Payment MUST accompany your registration application to secure a space, and should be mailed to the Post Office Box on the application ONLY.
- Exam availability changes daily. Register early. Refer to this schedule each time you register yourself or another for an exam.
- Cutoff dates are firm. However, an exam may be closed to further applications early should it reach capacity prior to the cutoff date.
- When an exam reaches capacity, it will be reflected on this schedule. No further applications will be accepted once an exam has reached capacity.
- You are allowed to reschedule a paper-based exam one time only. If you need to reschedule more than one time, you are subject to another exam fee. Exam fees are non-refundable, and credit will not be issued.
- **WEB-BASED EXAMINATIONS CANNOT BE RESCHEDULED! Neither credit nor refund will be issued if you are unable to attend a web-based examination. BE CERTAIN YOU CAN ATTEND THE EXAM BEFORE REGISTERING!**
- **PLEASE PLAN TO ARRIVE FOR YOUR EXAM NO LATER THAN 8:45AM.**
- **CELL PHONES ARE PROHIBITED IN EXAMINATION ROOMS! If you bring a cell phone, it must be turned off and left with the proctor for the duration of the exam. Neither the proctor nor MDE are responsible for personal cell phones.**
