Walter Reed Army Medical Center - Montgomery County

The Complaint and Order listed in the October 1998 *MDE Environment* has been settled for \$7,000. The penalty was issued for accumulating hazardous waste containers without proper closure and identification, other hazardous waste violations, and failure to properly maintain a fire extinguisher.

Status: Settled - Fine paid in full (Reference #C & O-99-001)

Zeal Tire, Prince George's County

A Complaint and Order involving a penalty of \$9,000 was issued against Zeal Tire for violations of their secondary scrap tire license. The company had stockpiled tires in excess of the 1,500 allowed by the license for greater than one year. A fire also occurred at the site. The company submitted an appeal to which the Administrative Law Judge issued a proposed decision upholding the department's penalty.

Eastern Correctional Institution (ECI) - Somerset County

On January 4, 1999, MDE signed an

administrative consent order with the Maryland Environmental Service (MES), operator of the co-generation plant at ECI. Under the terms of the consent order, MES has agreed to replace leaking cooling water towers at the facility by January 31, 1999.

Status: Case closed. (Reference # CO-99-0056).

Cherry Hill Construction, Inc. - Prince George's County

On January 7, 1999, MDE signed an administrative consent order with Cherry Hill Construction to resolve alleged violations of surface mining, erosion and sediment control laws resulting from operations at a site located at 5800 Sheriff Road, Capitol Heights, Maryland. Under the terms of the settlement, Cherry Hill Construction agreed to pay a penalty of \$20,000 for engaging in surface mining operations, grading and other land disturbance activities without the required permits and approvals.

Condea Vista - Baltimore City

MDE has finalized a settlement with Condea Vista concerning the October explosion at their Fairfield manufacturing facility. The settlement agreement requires Vista to conduct a thorough review of the causes of the explosion and requires implementation of equipment and measures to reduce the risks of another explosion. Vista is also required to conduct a facility-wide review of their operations to reduce further risk of safety or air pollution problems. The settlement also calls for Vista to provide training for their workers in proper and safe operation of their equipment. Further, the settlement requires Vista to pay a \$75,000 civil penalty for air pollution violations stemming from the October explosion. The air pollution violations were nuisance, particulate matter, and visible emissions.

Status: Case Settled. Vista has 20 days to pay the penalty.

Maugensville Feed - Washington County

MDE has finalized a settlement agreement with this Washington County feed mill for violations of Maryland's nuisance dust regulation. The settlement requires the Company to pay a \$5,500 penalty in monthly installments. In accordance with a Corrective Order previously issued by MDE, the Company is also implementing corrective measures to correct the violations and return to compliance.

Status: Case Settled. Maugensville must pay off its penalty in monthly installments and finish implementing corrective measures. (Reference # 97-06A)

Columbia Medical Supply, Inc. - Howard County

MDE assessed an administrative penalty against the Columbia Medical Supply Corporation in the amount of \$3,700 for violating the terms of its license for the possession and use of radioactive materials in the distribution of medical supplies. The violations included failure to notify MDE before relocation of the laboratory and supervision of the radioactive materials use program by an individual not authorized by the license.

Status: Case Pending. (Reference # RHP 98-21)

Western Maryland Health System - Allegany County

MDE assessed an administrative penalty against the Western Maryland Health System, Inc in the amount of \$3,000 for violations of the terms of its license and Maryland regulations for the possession and use of radioactive materials for medical purposes. The violations included improper recording of records for the transfer of packages of radioactive materials and improper labeling of waste containers used to dispose of needles contaminated with radioactive material in the Nuclear Medicine Department.

Status: Case Pending. (Reference # RHP 98-20)

During the period of explosive growth and intensive land use since the 1940s, Maryland lost approximately 60,000 acres of wetlands. In May of 1997, Governor Parris N. Glendening announced an initiative to restore the lost acreage. From the outset the Governor emphasized that the success of the wetlands initiative is dependent on the voluntary efforts from all sectors of Maryland's population. A Governor's Wetlands Restoration Steering Committee was appointed in January 1998.

To facilitate the committee's work, Maryland's communities were organized into six sectors: farmers, developers, miners, businesses, individual landowners and non-governmental organizations, and government. The committee believes that outreach to these six sectors is key to accelerating wetlands restoration in Maryland.

The committee will continue to identify impediments to restoration and will formulate recommendations on how to include all sectors in reaching the restoration goal.

To measure accomplishments toward the 60,000 acre goal, the committee has developed a tracking and accounting system. This system is the first concerted effort to accomplish all wetlands restoration efforts within the state in a single database.

The committee also is analyzing the available sources of wetlands restoration assistance. Although information exists on many of the programs, it may not be reaching its intended audiences. The committee is evaluating existing documents to identify what improvements may enhance the dissemination of information regarding needed assistance.

Technology also may assist in the restoration effort. Geographic Information System mapping will enable smart growth initiatives, wetlands restoration and conservation efforts at the state and local level to be evaluated.

The Governor also has provided incentive to the county governments to increase restoration projects by announcing a competition among the counties. The steering committee is following up with the counties on this challenge.
