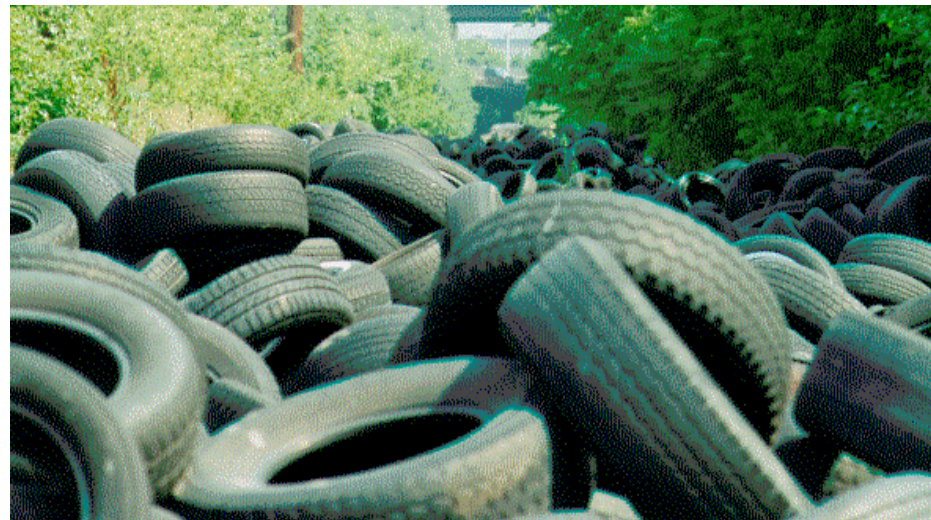

Scrap Tire Amnesty Day

A total of 135,000 passenger tire equivalence were disposed of April 25 during Scrap Tire Amnesty Day, sponsored by the Maryland Department of the Environment and the Maryland Environmental Service. The event, which allowed residents to dispose of up to ten scrap tires free of charge, was held in Allegany, Calvert, Caroline, Carroll, Charles, Dorchester, Frederick, Garrett, Kent, Queen Anne's, St. Mary's, Somerset, Talbot, Wicomico and Worcester Counties.

While each participating county was permitted to accept up to 75 tons of tires, equivalent to approximately 7,500 passenger tires, the event was so successful that some counties were able to exceed the 75-ton allotment. Subject to verification of tire counts all counties will be reimbursed for tires collected. Money for the project was provided by the Maryland Scrap Tire Fund which collects a \$1.00 per tire fee on the sale of each new tire in Maryland.

The environmental benefits did not stop with the collection of these scrap tires. Most of the tires were transported to a resource recovery facility where they were burned and converted to electrical energy.

St. Mary's County Metropolitan Commission - St. Mary's County

On May 4, 1998, MDE and St. Mary's Metropolitan Commission (METCOM) entered into an administrative consent order regarding the biological nutrient removal (BNR) upgrade of the Pine Hill Run Wastewater Treatment Plant located in Lexington Park. The consent order establishes interim effluent limitations for biochemical oxygen demand, total suspended solids, fecal coliform, total phosphorus and pH until the August 1, 1998 completion date for the upgrade. St. Mary's METCOM also agreed to pay stipulated penalties for violations of the interim effluent limitations.

Maritank, Inc. - Wicomico County

On April 15, 1998 a Complaint and Order and \$10,000 penalty was issued to Maritank, Inc., a petroleum terminal located in Salisbury, MD. On January 2, 1998 an above ground storage was overfilled during a marine transfer and the terminal operator failed to stop the transfer when the overfill alarm sounded. Additionally, the resulting spill was not reported to MDE within the required time limit.

Status: Pending (Reference #COV-98-034)

Central Precision - Washington County

On April 29, 1998 a Complaint and Administrative Penalty for \$5,000 was issued to Central Precision for improper disposal and management of hazardous waste at the company's Hagerstown facility. The company has not applied for a permit to treat, store, or dispose of hazardous waste. During a routine inspection it was discovered that 66 five gallon containers of waste thinner had accumulated and were stored in a shed without secondary containment, without labels or without noting accumulation dates. Additionally, the company had not notified EPA or MDE of its hazardous waste generator status nor did they obtain an EPA identification number. Various additional hazardous waste violations relating to the treatment, storage and disposal also were identified. **Status:** Pending (Reference #CAP-98-034)

Browning-Ferris, Inc. - Charles County

The Complaint Order and Administrative Penalty listed in the February 1998 MDEnvironment has been settled for \$50,000. The penalty was issued to the company for violations of the state sewage sludge utilization regulations--uneven spreading, failure to spread by end of the workday and a buffer zone violation at the Hickory Thicket site in Charles County. A Consent Order settled two sludge violations in Harford County for which site complaints had been issued earlier. BFI worked with MDE to resolve the compliance problems of its subcontractor, CDR Mid-Atlantic (all of the enumerated violations were committed by CDR under BFI permits). CDR had, in 1997, purchased the assets of Browning-Ferris, Inc. (a subsidiary of BFI) without obtaining their sludge permits, which are non-transferable. **Status:** Settled (Reference #C-O-AP-98-SS-035)

Landlords - Baltimore City; Kent, Carroll and Wicomico Counties

Eighteen landlords received penalty letters in April 1998 for failure to register 18 different rental properties. Under 1994 legislation passed to reduce the incidence of childhood lead poisoning. The law also requires landlords to perform certain lead hazard reduction treatments in registered properties.

Status: Pending (Various reference numbers)

Public Hearings Scheduled for Changes to Air Regs

Public hearings will be held on amendments to existing air quality regulations and on new regulations on July 22, 1998 at 9:30 a.m. at the Maryland State Office Building, 300 W. Preston St., 1st Floor Auditorium, Baltimore. These actions will:

- establish specifications and conditions that will allow used oil and high BTU value non-hazardous waste combustible fluid (WCF) to be burned as fuel (amend Regulations .01 and .02 and adopt new Regulation .10 under COMAR 26.11.09 Control of Fuel-Burning Equipment, Stationary Internal Combustion Engines, and Certain Fuel Burning Installations and repeal Regulation .06 under COMAR 26.11.11 Control of Petroleum Refineries and Petroleum Products Installations, including Asphalt Paving, Asphalt Concrete Plants, Motor Vehicle Fuel Storage and Use of Waste Oils);

- clarify specific Municipal Waste Combustor (MWC) requirements requested by the Environmental Protection Agency (EPA) concerning data availability, the training manual and a schedule for compliance (amend Regulations .08 and .09 under COMAR 26.11.08 Control of Incinerators);

- establish a visible emissions standard for Basic Oxygen Furnace (BOF) shops at integrated steel mills and delete portions of COMAR 26.11.10 that are no longer necessary (amend Regulation .04 under COMAR 26.11.01 General Administrative Provisions; amend Regulations .01-.05, repeal Regulation .06, and recodify Regulation .07 to become Regulation .06 under COMAR 26.11.10 Control of Iron and Steel Production Installations);

- repeal the petroleum refinery regulation that no longer serves its intended purpose and relocate the glass melting furnace regulations currently found in COMAR 26.11.16 to COMAR 26.11.25 to reserve COMAR 26.11.16 for the procedural requirements of Maryland's Air Toxics Program and lists of toxic air pollutants currently found in COMAR 26.11.15 (repeal Regulation .04 under COMAR 26.11.11 Control of Petroleum Refineries and Petroleum Products Installations, including Asphalt Paving, Asphalt Concrete Plants, Motor Vehicle Fuel Storage, and recodify Regulations .01 - .04

under COMAR 26.11.16 Control of Glass Melting Furnaces as Regulations .01 - .04 under COMAR 26.11.25 Control of Glass Melting Furnaces), and;

- adopt by reference all of the major source Maximum Achievable Control Technology (MACT) standards as adopted by EPA on or before July 1, 1998 and adopt minor recodification and clarification amendments (amend Regulation .01 under COMAR 26.11.01 General Administrative Provisions, amend Regulations .01 - .07 under COMAR 26.11.15 Toxic Air Pollutants and amend and recodify the procedures related to requirements for Toxic Air Pollutants formerly found in Regulations .07 - .14 under COMAR 26.11.15 to Regulations .01 - .09 under COMAR 26.11.16 Procedures Related to Requirements for Toxic Air Pollutants. Regulations .01 - .04 formerly codified under COMAR 26.11.16 have been recodified to COMAR 26.11.25),

The full text of these proposals will appear in the *Maryland Register* on June 19.

Except for the amendments to COMAR 26.11.15 and 26.11.16, all other amended and new regulations will be submitted to the U.S. EPA for approval.

The Federal Fiscal Year (FFY) 1998 Draft Intended Use Plans and FFY 1998/1999 Draft Project Priority Lists for Water Quality and Drinking Water Capital projects will be the subject of a public hearing to be held on Friday, July 17, 1998 at 10 a.m. in the Susquehanna Conference Room, First Floor, of the Maryland Department of the Environment located at 2500 Broening Highway in Baltimore.

The Draft Water Quality Intended Use Plan ("IUP") describes how the annual federal capitalization grant and matching state funds will be used for the design and construction of water quality capital projects pursuant to Title VI of the Clean Water Act. A federal grant of \$44,284,476 is anticipated for the Maryland Water Quality Revolving Loan Fund, which must be matched by \$8,856,895 in state funds.

The Draft Drinking Water Intended Use Plan describes how the annual federal capitalization grant and matching state funds will be used for the design and construction of drinking water capital projects, and for state and local activities to implement the requirements of the Safe Drinking Water Act. A federal grant of \$7,121,300 is anticipated for the Maryland Drinking Water Revolving Loan Fund, which must be matched by \$1,424,260 in state funds.

The Draft FFY 1998/1999 Project Priority Lists have been developed using pre-applications received from potential borrowers. Projects were rated and ranked based on public health and water quality benefits. The Priority Systems used to rate and rank the projects have been previously subjected to public comment and approval by the U.S. Environmental Protection Agency.
