tion of the Anacostia Watershed Restoration Committee (AWRC)

The AWRC coordinates these efforts and other restoration projects throughout the watershed. The Committee accomplishes this work within an ecologically based framework in the form of a Six Point Action Plan. The Plan is used to guide restoration efforts in the Anacostia,

and environmental indicators are being used to track restoration progress.

The AWRC, whose members include the District of Columbia and DC/WASA, Montgomery and Prince George's counties, the State of Maryland, the U.S. Environmental Protection Agency, and the U.S. Army Corps of Engineers, has also taken steps to strengthen its ties to the

residents of the watershed by forming the Anacostia Watershed Citizens Advisory Committee. The main purpose of the committee is to increase awareness of and improve communication between the AWRC and the community. While federal and State programs can help produce clean watersheds, the commitment and involvement of local governments,

communities, and citizens are key to cleaning up and maintaining rivers and streams on a watershed basis.

Refining Maryland's Water Quality Standards

Water Quality standards provide the foundation for many aspects of the Clean Water Act, including permits, listing impaired waters and developing TMDLs. The Clean Water Act requires that all states review their water quality standards every three years or triennially. This triennial review helps states to respond to changes in scientific understanding about ecological effects, new substances used in industrial processes, changes in available data about toxicity and biological accumulation of chemical substances.

Active public involvement is a key component of the review so that states can understand how the community views the status of its streams and rivers and can tap into local knowledge to improve environmental policy through more effective regulations. Maryland has begun its Triennial Review and has conducted four hearings to get public input on the existing water quality standards.

Based on the completed hearings, MDE findings and comments from EPA, the department will determine what revisions to our water quality standards might be appropriate.

However, after a cursory examination, it is already clear that some revisions will be necessary. These revisions, will be subject to additional public review and comment through the regulatory process.

Designated Uses

Maryland currently has seven designated uses for its waters (see sidebar). MDE has received comments asking the state to consider additional uses, such as exceptional warm water or cold water habitats, which would refine Use I and Use III respectively. Another option that MDE has been asked to consider is a modified warm water habitat for

streams in which the physical aspects of a stream have been so modified that different standards might need to be applied. Changes in uses such as these are a major step. If, after additional evaluation, MDE decides to move forward on any of these issues, additional public input would be sought.

Narrative and Numeric Criteria

Narrative and numeric criteria include general water quality, bacteriological, dissolved oxygen, temperature, pH, turbidity and toxic substance criteria. Numeric criteria are concentrations that should not be exceeded to assure protection of aquatic life. Narrative criteria describe substances, materials or effects that may be prohibited. For example, MDE is considering modifying its bacteriological standards and may adopt some additional criteria as well. MDE also will evaluate other chemicals that could be discharged and might need criteria.

Antidegradation

Antidegradation requirements enable Maryland to protect the quality of water where it is better than that required by the Designated Use. The State is considering adoption of a new designation called "Outstanding National Resource Water" (ONRW) described in the Clean Water Act as "Tier 3." An outlined approach framework for that designation is available from MDE's Technical and Regulatory Services Administration and comments are being sought on this framework. This designation would protect areas with special biological communities from new or additional discharges that might impair the water quality that these sensitive communities need.

Designated Uses for Maryland's Waterways

Each Maryland water body is assigned a use which is specified for each body or segment of body. Maryland currently has seven uses.

USE I and USE I-P waters are suitable for water contact sports; play and leisure activities where individuals may come in direct contact with the water; fishing; the growth and propagation of fish (other than trout), other aquatic life and wildlife; agricultural supply and industrial water supply. Use I-P also can provide a public water supply.

USE II Shellfish Harvesting waters support Use I and are where shellfish (oysters, softshell clams, hardshell clams and brackish water clams) are propagated, stored or gathered for marketing purposes.

USE III and USE III-P also support Use I and have the potential for, or are suitable for, the growth and propagation of trout and can support self-sustaining trout populations and their associated food organisms. Use III-P also can provide a public water supply.

USE IV and USE IV-P support Use I and includes cold or warm waters which have the potential for or are capable of holding or supporting adult trout for put and take fishing; and are managed as a special fishery by periodic stocking and seasonal catching. USE IV-P also can provide a public water supply.

Natural Wood Waste Recycling Facilities General Permit

Effective April 5, a general permit authorizing the operation of natural wood waste recycling facilities within Maryland has been introduced to replace individual permit authorizations. General permits enhance efficiency and reduce the time needed for the Maryland Department of the Environment (MDE) to issue permits to cover certain types of business activities performing similar functions while extending full environmental protection provided by law.

Unless an exception applies, the Code of Maryland Regulations (COMAR 26.04.09.04) requires that a person to obtain a permit to operate a natural wood waste recycling facility. Prior to April, the department fulfilled this obligation by issuing individual permits. However, since the conditions required for this type of operation are similar, regardless of location, and to date have been regulated by almost identical permit provisions, this type of activity is appropriate for

coverage under a general permit.

This general permit is a master permit containing conditions and parameters that apply to the operation of natural wood waste recycling facilities throughout Maryland. Responsible parties desiring to operate a natural wood waste recycling facility in Maryland under this general permit may submit a notice of intent to MDE.

There is no length of term for the master General Permit. Permittees may participate in the general permit for a maximum period of 5 years. Responsible parties covered under a General Permit may participate in the general permit for a maximum period of 5 years from the date of the letter of acknowledgement issued by the Department after receipt of the notice of intent. If eligible for renewal, the permittee shall submit a renewal notice of intent within 14 days prior to the expiration of that 5 year period.
