## Governors call for national bay effort

Maryland Governor Robert L. Ehrlich, Jr. and Virginia Governor Mark R. Warner announced the launch of an effort to make the clean-up of the Chesapeake Bay a new national priority. The announcement made Dec. 9 at the Chesapeake Bay Executive Council's annual meeting at George Mason University in Fairfax, Va., held at the site where the first Chesapeake Bay Agreement was signed 20 years ago.

"Finally, we have the political will in the Bay watershed states to fight for a national Chesapeake Bay restoration effort," Governor Ehrlich said. "I look forward to collaborating with Governor Warner, President Bush, and my former colleagues in Congress to promote a responsible, national stewardship of the Chesapeake Bay. Here in Maryland, I will continue working with legislators,

farmers, watermen, and conservationists to restore the oyster population, increase Bay grasses, and reduce harmful nutrients entering the Bay."

Governor Ehrlich will leverage his relationships in Washington, D.C. to secure federal support for the Chesapeake Bay. As a Member of Congress in 2001, Ehrlich co-authored legislation authorizing \$660 million to upgrade Bay-area wastewater treatment plants, which are the primary nitrogen pollutants of the Chesapeake Bay.

"It is appropriate that the Bay states join together in this collective effort to make the Chesapeake Bay a national priority," said Governor Warner. "Our federal government is the financial patron of the world's largest ecosystem restoration effort in the Florida Everglades. The Chesapeake

apeake Bay is a national treasure, and is also worthy of such extensive federal support."

Governor Ehrlich and Gover-

nor Warner are initiating plans to take the Chesapeake Bay effort to a national level and create a task

## Land preservation criteria change

Demonstrating his commitment to restoring the Chesapeake Bay with science-based policy initiatives, Governor Robert L. Ehrlich, Jr., recently announced a new focus in land conservation and preservation based on its relevance to protecting and preserving the Chesapeake Bay.

The criteria used to evaluate the State's land preservation purchases will be expanded to now include a comprehensive set of ecological indicators. Land will be identified and prioritized for purchase based on the application of these guidelines.

Given Maryland's current fiscal realities along with broad

public support for the state's land conservation programs, the new policy will ensure the land most critical to the Chesapeake Bay restoration is preserved and

## Attorney General, Acting Secretary give environmental lessons

force of all affected states and the District, to develop a plan to fully engage each congressional delegation, the President, state and local agencies, the Chesapeake Bay Foundation and other conservation groups to make restoration of the Bay a national priority. The Chesapeake Bay program estimates the cost of restoration at more than \$11.5 billion over the next 10 years.

The six-partner Chesapeake Executive Council also announced the formation of a Chesapeake Bay Watershed Blue Ribbon Panel to consider funding sources at a federal, state, and local level. The Panel will provide the Executive Council with

a detailed report no later than Oct. 2004.

Governor Ehrlich also highlighted three priorities to restore the Bay in Maryland: restoring the oyster population, increasing Bay grasses, and reducing nutrients entering the Bay. With oysters, Maryland is working with the EPA and the Army Corps of Engineers to accelerate the environmental impact study on introducing the Pacific coast strain of the Asian oyster into the Bay. The oyster will not only return the necessary filtration function to the Bay but will revive the nearly-dead oyster industry.

With bay grasses, Maryland will initiate a major propagation and planting program to meet the Chesapeake

2000 goal of 185,000 acres by the year 2010. Bay grasses produce oxygen, absorb nutrients such as phosphorus and nitrogen, provide food for a variety of animals, provide shelter and nursery areas for a variety of fish and shellfish, reduce wave action and shoreline erosion, and trap sediments. Bay grasses are critical to restoring the balance of the Chesapeake ecosystem.

With regard to nutrient reduction, Maryland is working to apply nutrient reduction technology on sewage treatment plants to achieve the water quality standards consistent with the Chesapeake 2000 Agreement. Bay Program partners will begin to develop Chesapeake Bay

watershed-based permitting strategies in upcoming months through a stakeholder-based process. The strategies will accelerate nutrient reduction efforts by ensuring that future pollution permits meet local water quality standards as well as those downstream in the Chesapeake Bay.

Executive Council members also agreed to a five-fold expansion of the current forest buffer restoration goal and also amended the Blue Crab Fishery Management Plan to include new harvest targets and thresholds.

The 64,000-square-mile Chesapeake Bay watershed is home to more than 16 million people and 3,600 animal species.

protected from development. It will, in effect, ensure Maryland's land preservation efforts are maximized with the funding provided. The new criteria will be used to evaluate purchases through the Program Open Space, Rural Legacy and GreenPrint programs.

It also recognizes the need to continue state support for outdoor recreational facilities for Maryland's communities, and to protect the land base for agricultural and forestry industries.

### Air & Radiation Management Administration

**Robert Blythe – Montgomery County**--On Nov. 3, a Complaint, Order, and Administrative Penalty for \$1,000 was issued to Dr. Robert Blythe for failure to register a radiation machine facility. The radiation machine was installed in May 2002. Despite multiple attempts for compliance assistance with the registrant, the radiation machine facility was not registered until April 2003. **Status:** Dr. Blythe has 10 days to appeal the Order. (Reference #RHP 03-04)

## Enforcement & Compliance Notes --Nov. 1 to Dec. 15, 2003--

**Comprehensive Orthopedic Services and Sports Medicine Center – Charles County**--On Nov. 3, a Complaint, Order, and Administrative Penalty for \$10,000 was issued to Comprehensive Orthopedic Services and Sports Medicine Center for failure to certify and for continued use of an uncertified radiation machine. The state certification for the radiation machine facility expired on July 1, 2002. **Status:** Comprehensive Orthopedic has 10 days to appeal the Order. (Reference #RHP 03-05)

**Ingber, Prestipino & Kratz – Montgomery County**--On Nov. 3, a Complaint, Order, and

Administrative Penalty for \$1,000 was issued to Ingber Prestipino & Kratz for failing to renew the radiation machine facility registration. This facility has failed to pay over \$1,000 in annual fees dating back to 2001. **Status:** Ingber, Prestipino & Kratz has 10 days to appeal the Order. (Reference #RHP 03-13)

**Oxon Hill Animal Hospital – Prince George's County**--On Nov. 17, MDE issued a Complaint, Order and Administrative Penalty for \$1,000 to Oxon Hill Animal Hospital for failure to renew registration of a radiation machine facility. The facility has failed to pay annual fees or

submit a renewal registration. Oxon Hill Animal Hospital agreed to pay the Penalty. **Status:** Oxon Hill Animal Hospital has 30 days to pay the Penalty. (Reference #RHP 03-19)

**Clinton Animal Hospital – Prince George's County**--On Nov. 17, MDE issued a Complaint, Order and Administrative Penalty for \$1,000 to Clinton Animal Hospital for failure to renew registration of a radiation machine facility. The facility has failed to pay annual fees or submit a renewal registration. The new owner has registered the radiation machine facility.

**Status:** Case closed. (Reference #RHP 03-20)

**Maury Fechter – Baltimore County**--On November 17, MDE issued a Complaint, Order and Administrative Penalty for \$10,000 to Maury Fechter for authorizing dental radiographic procedures to members of the general public without being a licensed practitioner of the healing arts. During a triennial inspection, Mr. Fechter failed to provide a current license, registration, or certification renewal to demonstrate he is an authorized dentist by the Maryland Board of Dental Examiners. **Status:** Maury Fechter has 10 days to appeal the Order. (Reference #RHP 03-28)

**BP Products North America, Inc. (BP)**--On Nov. 18, MDE signed an Agreement with BP Amoco to resolve an air quality compliance issue concerning air quality vapor recovery regulations. BP purchased Amoco and found that many of its recently acquired stations require extensive modification to comply with air quality vapor recovery requirements. This Agreement allows BP until December 31, 2004 to complete the retrofits in order to be in full compliance. It also requires that BP submit quarterly progress reports to MDE. **Status:** Case closed. (Reference #AQCP 031118)

**Constellation's Gould Street Plant – Baltimore City**--On Nov. 26, MDE and Constellation signed a Consent Order that addresses air quality violations at Constellation's Gould Street electrical generating plant in Baltimore. MDE staff documented numerous visible emission violations at the facility that occurred from July 2001

through January 2003. The Consent Order requires Constellation to pay a penalty of \$30,000 and complete a Supplemental Environmental Project (SEP) valued at \$40,000. The SEP requires that Constellation conduct combustion and efficiency analyses of specific Baltimore City school boilers and then implement repairs and modifications to improve energy efficiency and reduce emissions. The SEP is to be completed within 12 months. The Gould Street plant is no longer operating due to mechanical failure. **Status:** Constellation has 30 days to pay the Penalty. (Reference #AQCP 031126)

**Corrective Orders For Air Quality Vapor Recovery Violations:** On Nov. 26, MDE issued Corrective Orders to five gas stations for various violations of air quality vapor recovery regulations. The violations were determined during MDE inspections at the facilities. The Orders require the facilities to comply with the regulations and to submit a plan within 30 days to show how they will prevent violations in the future. **Status:** The gas stations have 10 days to appeal the Order. (Reference #AQCP 030507-10 and 030601)

**Goddard Space Flight Center – Prince George's County**--On Dec. 2, MDE issued a Corrective Order to Goddard Space Flight Center for violations of the facility's air quality operating permit. The Corrective Order requires Goddard to submit to MDE a plan to achieve compliance with its operating permit. MDE inspectors have determined that the facility has frequently failed to perform monitoring and record keeping re-

quired by the operating permit. **Status:** Goddard has 10 days to appeal the Order. (Reference #AQCP 030901)

**Froehling & Robertson - Baltimore City**--On December 1, MDE issued an Administrative Penalty for \$3,300 to Robert Mashewski for failure to report the loss of a portable nuclear gauge, failure to conduct annual radiation safety audits, failure to calibrate all radiation safety meters, and failure to have all appropriate radioactive material disposal records. **Status:** Froehling & Robertson has 30 days to pay the Penalty. (Reference #RHP 02-21)

## Waste Management Administration

**Viron Pepco Services Partnership - Prince George's County**-- Viron Pepco Services Partnership was issued a Complaint, Order and Civil Penalty equaling \$5,000 on Nov. 20 for violating Maryland's Hazardous Waste Laws by improperly storing and transporting spent fluorescent lighting tubes. **Status:** Viron Pepco Services Partnership has 10 days to request a hearing on the Complaint and Order and 30 days to request a hearing on the Penalty. (Reference No. CAP -04-021)

**Koons Ford of Annapolis, Inc. – Anne Arundel County** - Koons Ford of Annapolis, Inc. was issued a Complaint, Order and Civil Penalty on Nov. 25 for \$10,000 for violating Maryland's Oil Pollution Laws. Specifically, Koons Ford of Annapolis, Inc. failed to maintain proper inventory control and have an approved method of release detection in use on a 4,000 gallon gasoline underground storage tank system. **Status:** Koons Ford of Annapolis, Inc. has 10 days to request a hearing on the Complaint and Order and 30 days to request a hearing on the Penalty. (Reference No. COV-2004-001)

**Bernard Kapiloff & DAB – Andard Ltd. Partnership – Baltimore City** - Bernard Kapiloff & DAB – Andard Ltd. Partnership were issued a Complaint, Order and two \$5,000 Civil Penalties on Dec. 1 for illegal storage and disposal of scrap tires on two Baltimore City properties. **Status:** Bernard Kapiloff & DAB – Andard Ltd. Partnership has 10 days to request a hearing on the Complaint and Order and 30 days to request a hearing on the Penalty. (Reference No. C-O-AP-04-ST-138)

**Laurena Shields – Baltimore City** - Laurena Shields was issued a Complaint, Order and Civil Penalty totaling \$13,000 on December 5 for violating Maryland's Lead Laws by failing to register pre-1950 rental units and failing to obtain risk reduction certificates of lead inspection compliance. **Status:** Laurena Shields has 10 days to request a hearing on the Complaint and Order and 30 days to request a hearing on the Penalty. (Reference No. 02-30-5262)

## Water Management Administration

**Passyn & Passyn, L.L.C., Talbot County** – On Nov. 7, MDE filed an Amended Complaint for Civil Penalty against Passyn & Passyn, L.L.C. in the Circuit Court for Talbot County for alleged violations of stormwater management, sediment pollution, sediment control, and water pollution control laws while engaged in construction activities at the Doncaster Subdivision in Talbot County. This action amends the Complaint filed by MDE against Passyn & Passyn, L.L.C., Otwell Engineering, Inc. and Pin Oak Construction, Inc. on January 15, 2003. **Status:** Case pending. (Reference #JC-04-0058)
