CITGO Petroleum Corporation – Baltimore City

On September 15, 1998, MDE issued an administrative order to CITGO for failing to secure the necessary air pollution control permit prior to installing a tank containing volatile organic compounds and for creating nuisance odors associated with several small-volume gasoline spills that occurred during truck loading operations at the company's bulk gasoline terminal on Southport Avenue in June and July, 1998. The order required the company to submit a corrective action plan within 30 days for eliminating gasoline spills at the terminal.
Status: Case pending (Reference # 98-08-03)

Interstate Corrpac, Inc. – Dorchester County

On September 15, 1998, MDE issued an administrative order to Interstate Corrpac, Inc. for failing to secure an air pollution control permit prior to installing a printing press at the company's cardboard manufacturing facility on Woods Road. The order required the company to refrain from operating the press until the permit is obtained.

EMA Environmental Managed Abatement – Baltimore City

On October 13, 1998, MDE assessed a \$3,000 administrative penalty against this Baltimore asbestos abatement company for not notifying MDE of an asbestos removal project until after the project was completed and for failing to provide MDE with a record of disposal of the removed material. The asbestos removal occurred on North Main St. in Bel Air.

Anabel Environmental, Inc. – Gaithersburg

On September 24, 1998, MDE issued a complaint and assessed a \$5,800 administrative penalty against this laboratory services company for possessing and operating a lab device utilizing a radioactive material under an expired radioactive materials license and for failing to perform radiation leak tests on the device. These regulatory violations have occurred on more than one occasion.

Mid-Atlantic Infrared Services, Inc. – Bethesda

On September 29, 1998, MDE issued an administrative order and assessed an administrative penalty in the amount of \$1,500 against Mid-Atlantic for failing to conduct leak tests on a moisture density gauge, a device containing radioactive

material for which the company holds a radioactive materials license. Recordkeeping deficiencies and the company's failure to provide MDE with an opportunity to inspect the manner in which the company uses the gauge were also factors leading to the issuance of the order. The order requires Mid-Atlantic to cease using the gauge until MDE is notified that the gauge will no longer be used permanently or the company demonstrates that good operating practices occur when the gauge is used.

Status: Case pending (Reference # RHP 98-17)

Dean Guy – Pocomoke City

On October 9, 1998, MDE assessed an administrative penalty in the amount of \$3,700 against this individual for demolishing a structure with exterior transite shingles containing asbestos and for setting the rubble from the demolition on fire. These activities constituted an asbestos removal project under Maryland's air pollution control regulations. As such, appropriate measures should have been taken to protect the public from being exposed to asbestos. The structure was located at Laurel and Riverside Drive in Pocomoke City.

Status: Case pending (Reference #ACP 97-22A)

George's Creek and Celanese WWTPs– Allegany County

On October 9, 1998, a civil consent judgment was filed in the Circuit Court of Allegany County between MDE and the Allegany County Commissioners for violations of the NPDES permits issued to the George's Creek and Celanese Wastewater Treatment Plants. Under the terms of the Consent Judgment, Allegany County agreed to implement improvements to the wastewater treatment plants to ensure compliance with discharge permit effluent limitations and to address excessive inflow and infiltration problems associated with the plants' sewage collection systems. In settlement of past violations, the County agreed to pay a civil penalty of \$40,000, to be paid in annual installments over the next four years, and, within the next two years perform a supplemental environmental project worth \$200,000 to benefit water quality.

Status: The case is pending final approval of the court. (Reference # CJ-99-0041).

Marina Villages of Ocean Pines, L.P. – Worcester County

On October 6, 1998, an administrative

consent order was issued to Marina Villages of Ocean Pines settling the August 26, 1998 Stop Work Order. MDE issued the Stop Work Order against the marina for using a floating pier and breakwater system consisting of used tires as the flotation device in violation of Tidal Wetland License No. 94-WL-1070R. Under the terms of the consent order, Marina Villages agreed to post a \$25,000 bond and implement an approved inspection and maintenance plan for the piers and breakwater system.

Status: Marina Villages must post bond by October 21, 1998 and submit final plans for inspection and maintenance of the pier and breakwater system by January 6, 1999. (Reference # CO-99-0042).

Garrett County Sanitary District – Garrett County

On October 1, 1998, an administrative consent order was issued to the Garrett County Sanitary District resolving NPDES permit violations at the Friendsville Wastewater Treatment Plant resulting from excessive inflow and infiltration problems.

Status: Under the terms of the consent order, the Sanitary District agreed to implement improvements to the plant's sewage collection system, limit connections to the system and monitor performance of the plant during the next year to demonstrate compliance. (Reference #CO-99-0030).

Duncan Petroleum Corp., Camden, Delaware

On September 29 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$51,000 against the Duncan Petroleum Corp. for failure to perform release detection on underground gasoline storage tanks at five convenience and liquor stores owned by them on Maryland's Eastern Shore. The company has been cited previously for similar violations at their Maryland operations. The operators of the five stores are each charged individually and listed below.

Status: Pending (Reference #COV-93-003)

Beverage World, Inc. Wicomico County

On September 29, 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$5,000 against Beverage World, Inc. for operating an UST system without a method of release detection and for failure to operate and maintain the line leak detector as required. During a routine inspection MDE discovered that a gasoline pipeline had not passed a line leak test in at least 33

days and that the station continued to pump gasoline. A subsequent inspection revealed that the line leak test had still not been performed and that Beverage World, Inc. still continued to pump gasoline.

Status: Pending (Reference #COV-99-019)

Delta Beverages, Inc., Wicomico County

On September 29, 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$2,000 against Delta Beverages, Inc. for operating an UST system without a method of release detection and for failure to operate and maintain the line leak detector as required. During a routine inspection MDE discovered that the electronic line leak detector control unit was not operational.

Status: Pending (Reference #COV-99-022)

Easton Super Soda Center, Inc., Talbot County

On September 29, 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$7,000 against the Easton Super Soda Center, Inc. for operating an UST system without a method of release detection and for failure to operate and maintain the line leak detector as required. During a routine inspection MDE discovered that the alarm indicated that the pipeline had not passed a line leak test in at least 33 days and that the station continued to pump gas. A follow-up inspection indicated that the system had since been rewired to bypass the automatic shut off so the pump could continue to dispense product.

Status: Pending (Ref. #COV-99-023)

Preston Super Soda, Inc., Caroline County

On September 29, 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$4,000 against Preston Super Soda, Inc. for operating an UST system without a method of release detection and for failure to operate and maintain the line leak detector as required. During a routine inspection MDE discovered that the wires for the electronic line leak detector control unit had been rewired to bypass the unit.

Status: Pending (Reference #COV-99-021)

T & W Beverage, Inc., Caroline County

On September 29, 1998, MDE issued a Complaint, Order, and civil penalty in the amount of \$3,000 against T & W Beverage, Inc. for operating an UST system without a method of release detection and for failure to operate and maintain the line leak detector as required. During a routine inspection MDE discovered that two underground tanks were not equipped with automatic pressure drop line leak detector probes. During a subsequent visit the inspector discovered that the release detection monitoring system was turned off, as was the electronic line leak detector control unit.
