III.ARWG Forum Focus –
Developing Broader Public/Private and Federal/State/Local Partnerships10:10 – 11:15 am

- <u>Discussion</u>: The 4th quarter focus area for the ARWG is to address new partnerships that may be needed to advance adaptation goals in Maryland. Having spent previous forums exploring tool delivery for local governments; economic and investment decisions; and challenges facing low income and vulnerable communities, the ARWG will use this forum to discuss partnership opportunities that include business and industry representatives and local and university partners.
- <u>Requested Decision</u>: Discussion of opportunities to effectively connect members' work together, engage new partners and collaborate with other work groups to enhance adaptation impacts.
- A. Engaging Small Businesses in Maryland on Climate Change10:10 10:35 amKaty Maher, Center for Climate and Energy Solutions (C2ES)10:10 10:35 am
 - <u>Discussion:</u> The Center for Climate and Energy Solutions (C2ES) will present on recommendations for engaging small- and medium-sized businesses in Maryland on climate change resilience. This will include challenges and risks small businesses face, resources and information that are needed, and how to best

support businesses in enhancing resilience to extreme weather and climate change.

B. Local Capacity, Regional Coordination Brian Ambrette, Eastern Shore Land Conservancy 10:35 - 11:00 am

- Discussion: With funding from the Town Creek Foundation, the Eastern Shore Land Conservancy (ESLC) and Antioch University's Center for Climate Preparedness and Community Resilience piloted a regional capacity building project for climate resilience on the Eastern Shore. The pilot project successfully launched the Eastern Shore Coastal Resilience Facilitated Community of Practice, which includes participants from five county governments (Caroline, Dorchester, Kent, Queen Anne's, and Talbot), three municipalities (Cambridge, Chestertown, and Oxford), four state agencies (DNR, MDE, MEMA, and the Critical Area Commission), four academic institutions (UMD Sea Grant Extension, UMCES, Washington College, and Chesapeake College), and one nonprofit organization (ESLC). As of October 2016, the Community of Practice is drafting goals and a list of possible collaborative initiatives. Priority work areas will include:
 - Assisting communities and expanding capacity for risk reduction and preparedness
 - Facilitating information and knowledge exchange between members
 - Promoting education for members, residents, and elected leaders
- C. Expanding Facilitated Communities of Practice 11:00 11:15 am Abigail Abrash Walton, Antioch University (call in)
 - Discussion:The Center for Climate Preparedness and Community Resilience has conducted a
range of climate preparedness capacity-building programs, including the April
2016 Local Solutions: Eastern Regional Climate Preparedness Conference,
convened in partnership with U.S. EPA in Baltimore, MD. This presentation will
include findings from the pilot Eastern Shore Coastal Resilience Facilitated
Community of Practice, conducted in collaboration with the Eastern Shore Land
Conservancy, and from the Center's just-released Local Solutions Report:
Identifying and meeting the needs of local communities adapting to a changing
climate. Opportunities may exist to replicate this FCoP model as a means of
building sustainable cross-jurisdictional, cross-functional collaboration to advance
resilience at the local scale.

 - <u>Discussion</u>: The Georgetown Climate Center presented at the 3rd quarterly forum about its work for the Town Creek Foundation and ARWG regarding examples of addressing adaptation. Since their draft report was circulated DNR staff have worked with GCC to identify possible opportunities and recommendations that are consistent with 2016's discussions at the quarterly forums.
