

# ACC II & ACT Working Group Recommendations





## Rec 1: Build IIJA and IRA EV Infrastructure by 2028




- Build federally funded infrastructure by the end of 2028 at the latest.
- Build infrastructure at the scale needed to support the larger, more varied EV fleet of the 2030s.
- The NEVI funds should be used for future proofed highway charging, with more, and higher speed (250-350 kW) stalls and more stations, to the extent still possible.
- Improve public communication from state agencies around infrastructure buildout.



## **Rec 2: PSC Should Ensure Timely Grid Upgrades**



- The PSC should require utilities to proactively upgrade distribution grids and energize charging infrastructure expeditiously and according to timelines.
- Utilities should facilitate and compensate ratepayers for vehicle-to-grid power flows, reform demand charges, provide Fleet Advisory Services, and allow for flexible service interconnections.
- Utilities should target their programs toward, and engage with stakeholders in, underserved communities, targeting multi-unit dwellings specifically.



## **Rec 3: Incentivizing Community Charging**






- The PSC should approve utility investments in community charging, with an enhanced emphasis on multi-unit dwellings.
- Policies that target multi-unit dwellings should consider financial incentives to multi-unit building owners and operators, grants, and building codes updates for new buildings.
- Set requirements for DHCD to install charging or allow third party installation.
- Require agencies to expedite processing of community charging projects funded through Maryland's CFI grants.

### Rec 4: Form a Secretary-Level Task Force to Accelerate EVs



- This task force should evaluate state agencies' progress with building charging infrastructure; how they can more effectively coordinate; and how to accelerate EV adoption.
- Include the Governor's Office, MDOT, the PSC, MEA, MDE, the Attorney General, and DHCD, at a minimum.
- State agencies should regularly communicate and coordinate on matters such as:
  - Challenging the Trump Administration's unlawful freeze of nearly \$70 million in IIJA CFI funds that were awarded to Maryland.



#### Rec 5: Retain ACC II and ACT "On the Books"



- Maryland should keep its ACT and ACC II regulations in place, and ensure that reporting requirements continue to be followed.
- The Governor should support, and join, agreements on EV sales commitments with manufacturers that other states are pursuing.
- The Governor should require reporting OEMs and vehicle dealerships to report on the amounts of annual advertising and sales expenditures for internal combustion engines (ICEs) and EVs.

#### **Rec 6: Additional Incentives and Policies**



- Adopt Advanced Clean Fleets standards.
- Empower Maryland's green banks to provide low/no-interest financing for EV purchases by businesses and individuals.
- Create funding mechanisms to defray the purchase price of M/HDVs like EV school and transit buses.
- Require large fleet operators to match the public IIJA & IRA funds with their own investments through programs such as a Clean Truck Fund and Indirect Source Review Rule.



#### **Process Recommendations**



- The Working Group should establish a firm process and timeline for the development of a report, including guidelines to foster achieving consensus.
- Provide clarity around the inclusion of majority and/or minority opinions on topics where consensus cannot be reached.
- This will ensure that the report truly reflects the expertise and perspectives of the diverse Work Group members, and is the product of thorough, thoughtful deliberations among these members.
