NOTICE OF INFORMATIONAL MEETING AND PUBLIC HEARING**

CORRECTION AND ANNOUNCEMENT OF SUPPLEMENTAL ON-LINE MEETING

On February 11 and February 18, 2022, MDE’s Land and Materials Administration published a public notice of tentative determination in the Baltimore Sun to renew a Controlled Hazardous Substance (CHS) facility permit previously issued to Baltimore Gas and Electric Company (BGE). The permit would allow BGE to continue to operate a CHS storage facility at 7210 Windsor Boulevard, Baltimore, MD 21244. The public notice offered an opportunity for any interested party to request a public hearing on the tentative determination.

MDE has received a request for a public hearing. In response to the request, MDE has scheduled an informational meeting, to be followed immediately by a public hearing. The informational meeting will begin at 7:00 pm on June 2, 2022 at the Dogwood Elementary School, 7215 Dogwood Road, Baltimore, MD 21244 (Windsor Mill area of Baltimore County). MDE will provide an interpreter for hearing impaired persons, if requested at least five workdays before the hearing date.

The informational meeting will provide information about facility operations and the draft permit renewal. The purpose of the public hearing is to provide a public forum for the submission of comments on the Department’s tentative determination to renew the permit. Comments may also be submitted in writing until close of business on June 13, 2022. Any supporting material which accompanies correspondence must be included in its entirety and may not be incorporated by reference, unless it is already part of the administrative record in the same proceeding, or it consists of State or Federal statutes and regulations, United States Environmental Protection Agency (EPA) documents of general applicability, or other generally available reference materials. Commenters must make supporting material not already included in the administrative record available to the Director.
