Dear Mr. Crandall:

The Air and Radiation Administration (“ARA”) of the Maryland Department of the Environment (“Department”) is contacting you as the representative of the owner of the above referenced Bauxite I Data Center Property at 3250 Digital Drive in Frederick, Maryland (“the Property”).

A final air quality permit is required prior to commencement of any construction on an air pollution emissions unit such as the emergency generators that are proposed to be installed at the Property. The Department has received an application for such a permit from Amazon Data Services, but has not made a final determination on that application, nor has the Department received an application from Rowan Digital.

While some construction activities for elements of a data center do not require an air quality permit, including construction of the core and shell of the building that will house the data center, other activities more directly associated with the emissions unit cannot be performed before the issuance of such a permit. Activities that constitute construction on an emissions unit include, but are not limited to, installation of building supports and foundations, laying underground pipework, and construction of permanent storage structures.

The Department has confirmed through our latest site visits that physical construction on emissions units commenced at the Property prior to the issuance of a final air permit to construct those emissions units. Specifically, the Department observed the construction of concrete foundations to support the proposed diesel-fired emergency generators, as well as the installation of associated electrical conduit and transformers.

The Department requires that all construction relating to emissions units cease immediately, until and unless a final air permit has been issued and a construction notification has been received by the Department. Please acknowledge receipt of this request within five (5) business days of the date of this letter. Failure to comply with the requirements set forth in this letter will result in a violation pursuant to COMAR 26.11.02.10A.
