Dear Mr. McNew:

This letter is written in response to a request from Eastern Petroleum Corporation to modify the completion dates related to three items within the March 12, 2009 Settlement Agreement and Consent Order entered into between the Maryland Department of the Environment and Eastern Petroleum Corporation regarding the above-referenced site. This request was made due to the ongoing removal of petroleum product lines at the site, the amount of petroleum impacted soil encountered during removal activities, and the unforeseen wet weather, all of which have delayed site activities.

Please find enclosed an Amendment to Settlement Agreement and Consent Order that you must sign and return. Upon receipt, I will sign and return a copy to you. The Department's Oil Control Program will approve the proposed schedule as outlined in the letter dated April 29, 2009 from Environmental Consultants LLC, submitted on behalf of Eastern Petroleum Corporation. The modified schedule to be approved is as follows:

- UST System Removal Completion May 22, 2009
- UST Closure Report Submit to MDE by July 3, 2009
- Site Supplemental Investigation Plan Submit to MDE by July 17, 2009

All other schedules and deadlines as established within the *Settlement Agreement and Consent Order* remain the same. All investigation and remediation activities before implementation or discontinuance must have prior approval of the Oil Control Program.
