RE: DISCRETE ZONE SAMPLING APPROVAL

Dear Mr. Bozeman:

The Maryland Department of the Environment's (the Department) Oil Control Program recently completed a review of the *HydraSleeve TM Sampling Proposal - 3627A Southside Avenue Supply Well*, dated July 20, 2017. The proposal was submitted per the *Supply Well Investigation Work Plan - 3627A Southside Avenue*, dated January 20, 2017 and MDE approval letter dated February 13, 2017. The *Work Plan* includes a proposal to collect ten discrete zone groundwater samples using HydraSleeve samplers at locations based on the results of the geophysical data for the drinking water supply well and the discrete zone analytical data collected from monitoring well MW-189D, located at 3605A Southside Avenue.

The Department approves the scope of work and the ten zones identified for discrete zone sampling via HydraSleeve samplers contingent upon the following modifications:

- 1. Include additional discrete zone samples at the following depths:
  - A. Collect a discrete zone sample at 90 feet below grade surface (bgs) (possible fracture 87.5 to 92.8 feet, partial open fracture at 90.04 feet bgs and possible flow).
  - B. Collect a discrete zone sample at 194.5 feet bgs (open fracture and possible flow).
- 2. A Report of Findings must be submitted to the Oil Control Program within 45 days following completion of discrete zone sampling, including a brief summary of field activities, analytical summary data table, gauging data, analytical data results, evaluation, and recommendations.
- 3. At this time, the Department approves suspending packer testing for sample collection pending data review of the HydraSleeve sampling results.
