RE: RESPONSE TO POTABLE SUPPLY WELL SAMPLING REDUCTION WORK PLAN

Case No. 2006-0303-BA Consent Decree Former Exxon R/S No. 2-8077 14258 Jarrettsville Pike, Phoenix Baltimore County, Maryland

Dear Mr. Lee:

The Maryland Department of the Environment's (MDE) Oil Control Program (OCP) completed a review of the *Potable Supply Well Sampling Reduction Work Plan*, dated June 11, 2024, and the *Third Quarter 2024 Groundwater Monitoring Report*, dated November 15, 2024, both prepared by Kleinfelder, Inc. (Kleinfelder) on behalf of ExxonMobil Environmental & Property Solutions (ExxonMobil). The work plan outlined a request to cease sampling of 24 of the 28 private supply wells (PSWs) that are currently sampled at various frequencies.

The proposal was based on the following conditions/criteria:

- The 24 PSWs have not had detections of petroleum hydrocarbon constituents in exceedance of MDE's drinking water standards for over 2 years;
- The 24 PSWs have not had detections of petroleum hydrocarbon constituents above half of MDE's drinking water standards for over 10 years;
- There are no ExxonMobil owned or managed point of entry treatment systems on any of the 24 properties proposed for discontinued PSW sampling; and
- There is no on-going remediation on any of the 24 properties proposed for discontinued PSW sampling.

The following items were considered as part of MDE's data review:

- The proximity of properties to the 2006 release area and areas of documented petroleum-related impacts (e.g., liquid, adsorbed, and dissolved phase hydrocarbons);
- The current concentrations in the PSWs:
- The historical sampling results and trends; and
- The proximity to groundwater monitoring and former recovery wells.

MDE has evaluated ExxonMobil's proposed changes to the PSW sampling requirements and based on the available information considered and reviewed provides the following summary with property specific details found in Table 1.

- MDE approves discontinuation of PSW sampling at 14 of the requested 24 properties, pending the results of a final round of sampling from each PSW. MDE will send a letter to each property owner notifying them of ExxonMobil's proposal and MDE's intention to approve the discontinuation of sampling from the PSW serving the property. The letter will inform them that the next sampling event will be the final event unless there is an unexpected result that needs further evaluation.
- MDE approves the continued PSW sampling of the four properties indicated and at the frequencies proposed by ExxonMobil.
- MDE requires the continued PSW sampling of the 10 properties indicated.

As discussed during the annual consent decree technical meeting on January 23, 2025, additional reductions to the PSW sampling program will be considered following completion of a minimum of two rounds of discrete zone sampling of the monitoring well network and a review of the sampling results in context with the spatial extents of the monitoring well network (i.e., in a three dimensional context).

While MDE agrees to these modifications to sampling pursuant to the Consent Decree and its negotiated requirements with respect to this case involving Former Exxon R/S No. 2-8077, the State of Maryland, including all its departments, reserves all rights against ExxonMobil with respect to all other past, present, and future cases to the State. The MDE reserves the right to require additional sampling based on new information, changing site conditions, or as a final sampling event prior to issuing case closure.
