Dear Secretary Kurtz:

The Maryland Department of the Environment has determined by sampling of the water and appropriate investigation that the area described below complies with the standards for the harvesting of shellfish. Therefore, pursuant to the Annotated Code of Maryland, Natural Resources Article § 4-742, MDE hereby reclassifies the area described below to approved for the harvesting of shellfish **effective February 5, 2024.**

North Prong, St. Jerome Creek, St. Mary's County (47Ab)

All of the waters of the North Prong, upstream of a line at a point on the west side of the prong (38°07'04.5" North Latitude, 76°21'20.9" West Longitude) running in a south easterly direction to a point on the east side of the prong (38°06'58.9" North Latitude, 76°21'11.5" West Longitude).

Mainstem, St. Jerome Creek, St. Mary's County (47Ad)

All of the waters of St. Jerome Creek upstream of a line at a point on the corner of a concrete and rock bulkhead on the west side of St. Jerome Creek (38°08'01.8" North Latitude, 76°20'59.3" West Longitude) running in a south easterly direction to a point on the east side of St. Jerome Creek (38°07'57.1" North Latitude, 76°20'43.8" West Longitude).

Malone Bay, St. Jerome Creek, St. Mary's County (47Ae)

All of the waters of Malone Bay upstream of a line at a point on the western shore of Malone Bay (38°07'36.7" North Latitude, 76°20'26.7" West Longitude) running in a southeasterly direction to a point on the east side of Malone Bay (38°07'32.2" North Latitude, 76°20'14.7" West Longitude).

The following area will remain restricted:

South Prong, St. Jerome Creek, St. Mary's County (47Aa)

All of the waters of the South Prong south of a line on the west side of the prong (38°07'7.9" North Latitude, 76°20'38.8" West Longitude) running in a north easterly direction to a point on the east side of the prong (38°07'9.0" North Latitude, 76°20'31.0" West Longitude).


