1. **Processing of payment DOES NOT reserve your slot. You can be turned away if you cannot show you received an acceptance email to the examination from the Board.**
2. **You will be notified of your acceptance into your requested exam via email. IT IS IMPERATIVE TO INCLUDE AN EMAIL ADDRESS ON YOUR APPLICATION!!!!**
3. Cutoff dates are firm. However, an exam may be closed to further applications early should it reach capacity prior to the cutoff date.
4. Exam availability changes daily. Register early. Refer to this schedule each time you register yourself or another for an exam.
5. You are allowed to reschedule a paper-based exam one time only. If you need to reschedule more than one time, you are subject to another exam fee. Exam fees are non-refundable, and credit will not be issued.
6. WEB-BASED EXAMINATIONS CANNOT BE RESCHEDULED! Neither credit nor refund will be issued if you are unable to attend a scheduled web-based examination. BE CERTAIN YOU CAN ATTEND THE EXAM BEFORE REGISTERING!
