NOTICE OF PUBLIC HEARING

Washington County

Application for State Discharge Permit 22DP3198, NDPES Permit MD0067741:

City of Hagerstown, 51 W. Memorial Blvd., Hagerstown, Maryland 21740, submitted to renew their application to discharge an average of 1,050,000 gallons per day of backwash from cleaning treatment filters from the W.M. Breichner Water Treatment Plant, located at 12136 Crystal Falls Dr., Smithsburg, MD 21783 to Antietam Creek (Use III-P waters). The plant is currently not operating and has not discharged since 2014.

The Department proposes to issue the permit with limits on Outfall 001 for total suspended solids (20 mg/L average, 30 mg/L maximum); total recoverable aluminum (4.0 mg/L average, 6.0 mg/L maximum); total residual chlorine (0.019 mg/L maximum); and pH (range of 6.5-8.5).

Monitoring without limits is proposed for flow and temperature. The permit includes requirements to avoid use of nutrient containing additives and requirements for potential lagoon decommissioning.

This facility is located on a census tract with an Environmental Justice (EJ) Score in the 26th percentile of all tracts in Maryland. This EJ score has been calculated considering a combination of the following factors: pollution burden exposure, pollution burden environmental effects, sensitive populations, and socioeconomic indicators (https://mdewwp.page.link/EJ).

Water St., Smithsburg, MD 21783.</u>

Persons who wish to present information regarding the tentative determination may speak at the public hearing, submit written comments at the public hearing, or submit a

written statement to the Department no later than <u>5 p.m. on December 17, 2024</u>. All comments will be considered in making a final determination.
