NOTICE OF PUBLIC HEARING

Allegany County

Application for State Discharge Permit 24DP2937, NDPES Permit MD0066079:

AES Warrior Run LP, 11600 Mexico Farms Rd, SE, Cumberland, MD 21502 submitted an application for renewal of a permit to discharge an average of 146,000 gallons per day (gpd) of cooling tower and boiler blowdown, demineralizer regeneration wastewater, and CO2 scrubber wastes and variable volumes of stormwater, including coal pile runoff, from a steam electric cogeneration and CO2 production facility, located at 11600 Mexico Farms Rd, SE, Cumberland, MD to the North Branch Potomac River (Use I-P waters). As of June 1, 2024, the facility has ceased coal-burning operations.

The Department (MDE) proposes to reissue the permit with the following limits on Outfall 001: flow from CO2 waste tank (30 gpd); pH (range of 6.0 to 9.0); total suspended solids (30 mg/L avg, 50 mg/L max); total residual oxidants (0.011 mg/L avg, 0.019 mg/L max); oil & grease (12 mg/L avg, 16 mg/L max); temp. (90°F max); chromium (0.1 mg/L avg, 0.1 mg/L max); copper (0.024 mg/L avg, 0.039 mg/L max); nickel (0.135 mg/L avg, 1.22 mg/L max); silver (0.022 mg/L avg, 0.022 mg/L max); and zinc (0.307 mg/L avg, 0.307 mg/L max). More restrictive limitations for copper, nickel, silver, and zinc based on updated background hardness are proposed following a 36-month compliance schedule (with interim milestones). Monitoring without limitations is proposed for hardness and sulfate. MDE proposes maximum limitations of 1.0 mg/L for iron and copper from chemical metal cleaning wastewater, to be segregated and monitored at Monitoring Point 101. The permit includes annual loading goals for total nitrogen (3,641 lbs/yr) and total phosphorus (166 lbs/yr) with an annual report requirement, a prohibition on the discharge of PCBs, a requirement for safe handling of fly ash, an approval process for new water treatment additives, hydrostatic testing limits, and a requirement for registration under the general permit for industrial stormwater.

This facility is located on a census tract with an Environmental Justice (EJ) Score in the 60th percentile of all tracts in Maryland. This EJ score has been calculated considering a combination of the following factors: pollution burden exposure, pollution burden environmental effects, sensitive populations, and socioeconomic indicators (<u>https://mdewwp.page.link/EJ</u>).

Persons who wish to present information regarding the tentative determination may speak at the public hearing, submit written comments at the public hearing, or submit a written statement to the Department no later than **<u>5 p.m. on January 31, 2025</u>**. All comments will be considered in making a final determination. Comments received via any submission mechanism will all be given equal weight.
