Per COMAR: Sand Mound systems all only be installed by an MDE certified Sand Mound installer and that installer must be onsite while the Sand Mound system is being installed. MDE does not certify companies. Certification shall be given to individuals who have successfully completed a course of study and examination in the practice of construction of mound systems. Sand Mound installer certification shall be valid for a period of 5 years and may be renewed by MDE at that time provided that the installer has complied with all of the appropriate laws and regulations.
