Project Description: U.S.ARMY CORPS OF ENGINEERS, REISSUANCE OF NATIONWIDE PERMITS- On September 15, 2020, the U.S. Army Corps of Engineers (Corps) published in the Federal Register its proposal to reissue the 52 existing nationwide permits (NWPs) and issue five new NWPs. The Water and Science Administration is reviewing a request for a State Water Quality Certification (WQC) and concurrence with the Coastal Zone Management Act consistency determination (CZMA). Pursuant to COMAR 26.08.02, Regulation .10 Water Quality Certification and 15 C.F.R. Section 930.42 Subpart C of the Coastal Zone Management Act., the Maryland Department of the Environment is required to give public notice. The purpose of the water quality certification is to advise the federal agency as to whether the permitted activity will or will not comply with Maryland's water quality standards. The purpose of the consistency determination is to advise the federal agency as to whether the federal activity will be consistent with Maryland Enforceable Policies approved under Maryland's Coastal Zone Management Program. The purpose of this public notice is to solicit comments from the public regarding the work described in the link below and provide opportunity to request a public hearing.
