This mitigation bank would provide compensatory mitigation for future stream and nontidal wetland impacts authorized by the Maryland Department of the Environment in the USGS 8-digit hydrologic unit code (HUC) of Monocacy (HUC 02070009) and the Piedmont physiographic region within the Middle Potomac-Catoctin (HUC 02070008). This proposed project includes grading and planting that would result in approximately 6.4 acres of wetland re-establishment, 1.86 acres of wetland enhancement, 10,807 linear feet of stream restoration, 330 linear feet of stream preservation, 34.44 acres of riparian buffer enhancement
