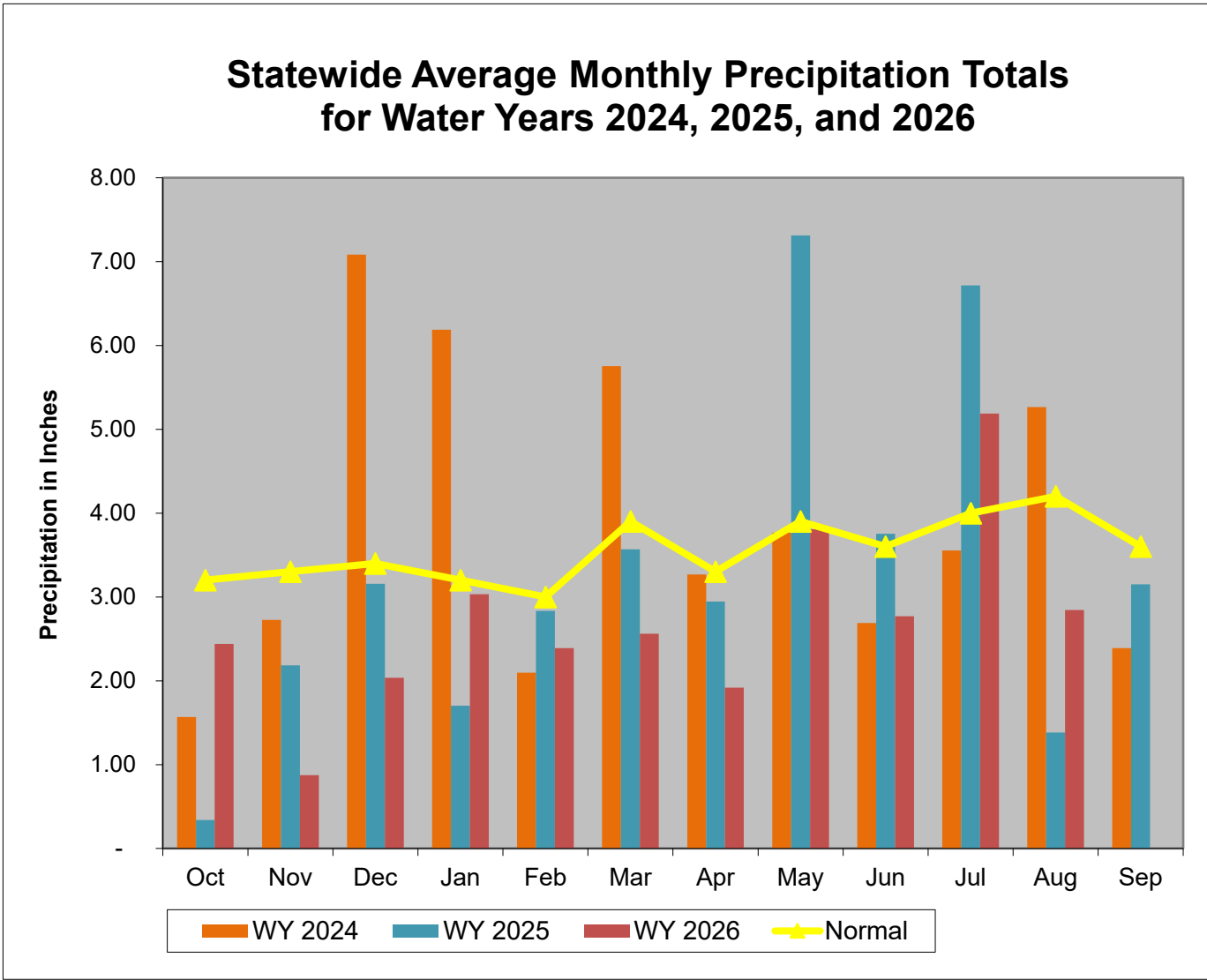

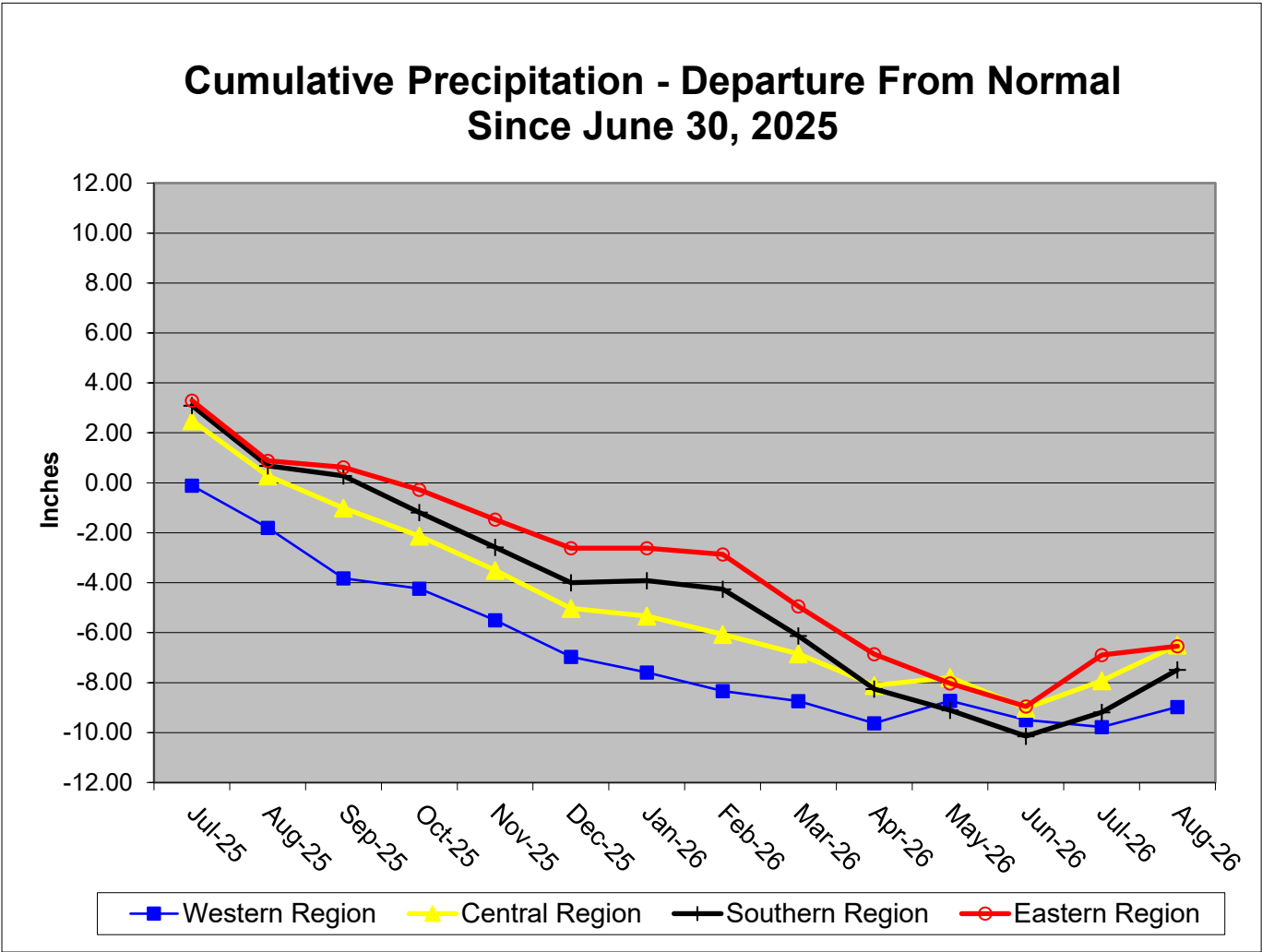

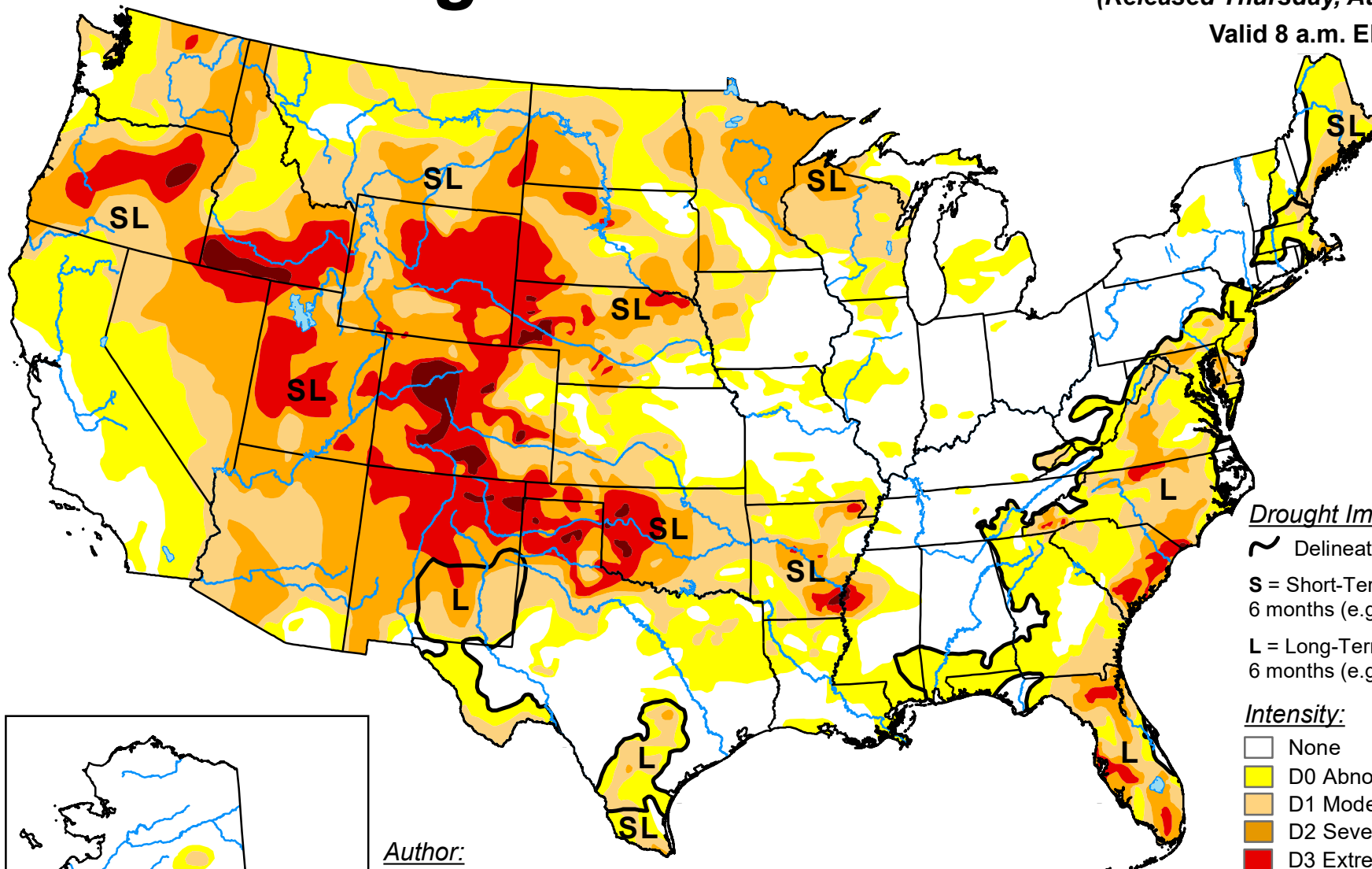

Drought Impact Types:

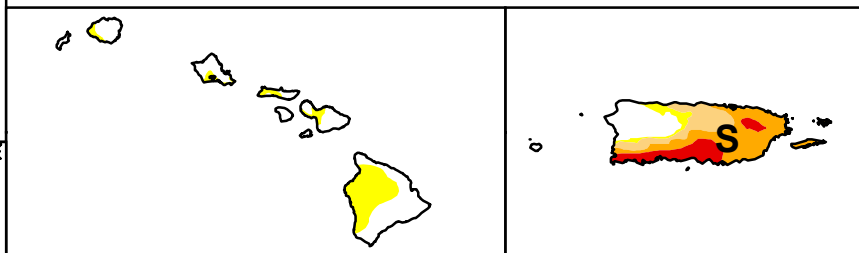
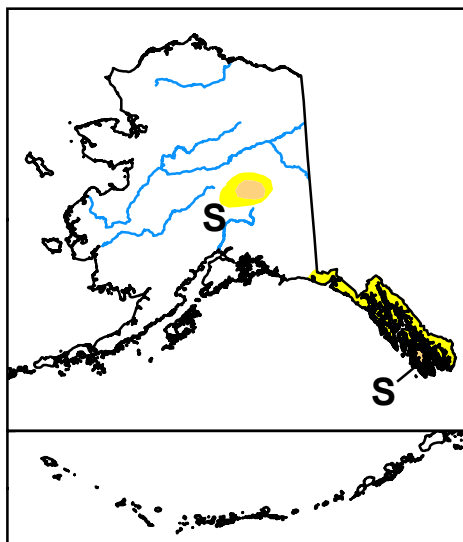
- ~ Delineates dominant impacts

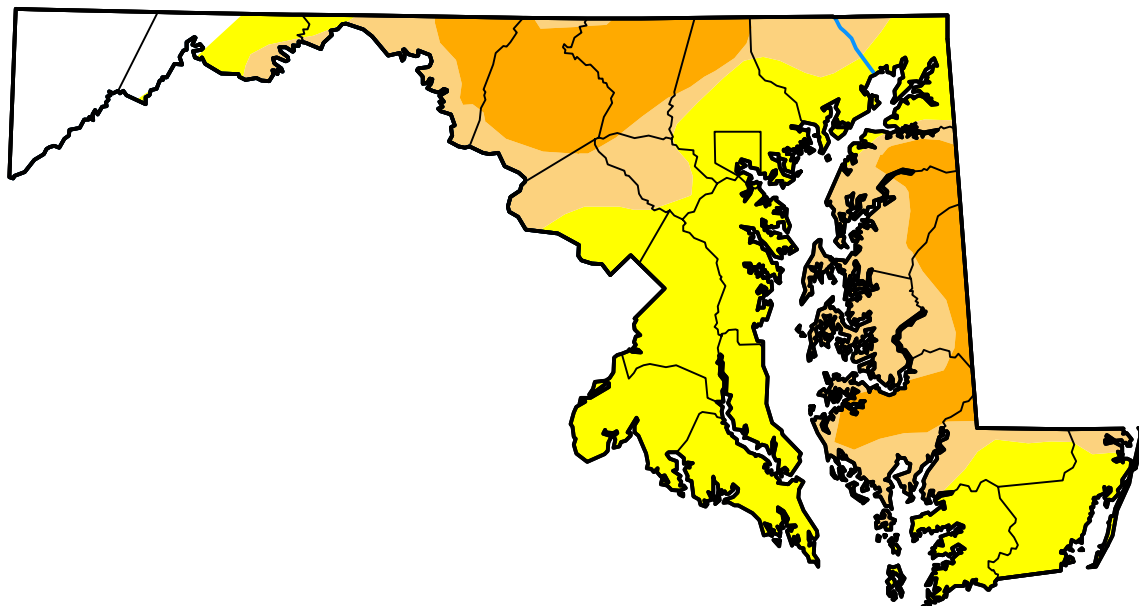
