Section I: Applicant Information

- (A) Provide the legal name of the person, business or other entity.
- **(B)** Provide the physical address of the Planned Food Processing Operation
- **(C)** Provide the mailing address, if different from the physical address.
- **(D)** Provide the type of food processing operation that will generate wastewater (brewery, winery, creamery, animal slaughter operation, etc.)
- **(E)** Provide a description of your food processing operation. Include a thorough description of each process that generates wastewater.

SECTION II: Food Processing Operation Information

- **(F)** Provide the average and maximum amount of wastewater, in gallons per day (gpd), that your operation generates. If existing, provide the date that production started.
- **(G)** Indicate how often wastewater is generated.
- **(H)** Identify any solid/semi-solid byproduct that will be generated and how it will be managed (hauled away, composted onsite, etc.)

SECTION III: Land Application of Food Processing Wastewater

- (I) Provide the amount of land available for the land application of food processing wastewater generated onsite in square feet or acres. (Indicate which unit.)
- (J) Describe the type of vegetation to which the wastewater will be applied.
- **(K)** Provide an estimate of amount of land necessary to properly manage the wastewater (i.e. to ensure no ponding or runoff occurs).
- **(L)** Provide the method that will be used to land apply the wastewater.

SECTION IV: Wastewater Storage

Wastewater cannot be land applied when the soil is bare, saturated, snow covered or frozen. MDA regulations (COMAR 15.20.07) also *prohibit land application of wastewater during the winter*. Winter is defined in Maryland statewide as December 16 through February 28 of the following year. Wastewater storage is therefore required.

- (M) Provide an estimate of the volume of a holding tank needed to store 7 days of wastewater.
- (N) Indicate whether or not you have existing wastewater storage. If so, provide the capacity of the holding tank, in gallons.
- **(O)** Provide the name of the entity that will haul wastewater offsite for appropriate treatment and disposal and a pump-and-haul schedule. An exemption will not be granted to operations that cannot demonstrate the proper management of wastewater during the winter months.

SECTION V: Nutrient Management Plan

- **(P)** Describe any ongoing farming activities and any sources of nutrients that are land applied (i.e. manure, chemical fertilizers, biosolids, etc.).
- (Q) Provide the name and certification number of the Nutrient Management Plan Developer, if applicable.

SECTION VI: Site Map and Wastewater Analysis

Please submit a map showing the location of the planned food processing operation and land application areas. This map should include streams, drinking water wells and septic systems.

A wastewater analysis of your process wastewater must be submitted in order to qualify for an exemption. Your wastewater analysis will be submitted to the State Chemist Office in order to determine if it meets the requirements for registration as a 'soil conditioner'. Your wastewater should be analyzed for the following constituents:

Ammonia (NH₃)
Total Kjeldahl Nitrogen (TKN)
Nitrite + Nitrate (NO₂ + NO₃)
Total Nitrogen (Total N)
Total Phosphorus (Total P)
Potassium (K)

If this is an existing operation or you are applying to renew your exemption, you must submit a copy of your Nutrient Management Plan (NMP).

Section VII: Certification

An original signature and date is required in order to process the application. By signing this application, the applicant agrees that they will comply with the requirements listed in the supplemental document "Requirements of an Operation Exempted from Obtaining a Discharge Permit for Land Applying Food Processing Wastewater."

HOW TO SUBMIT:

You must ensure that the form is completely filled out and the site map, wastewater analysis, and NMP (if applicable) is included with your application.

NOTE: You will be notified in writing of MDE's decision to grant a discharge permit exemption.
